### 2011 CENSUS SECOND RELEASE: FIRST RESULTS

On 11<sup>th</sup> December the Office for National Statistics (ONS) published Key Statistics for local authorities in England and Wales from the 2011 Census. This release marks the beginning of the release of detailed information about the characteristics of the people living in England and Wales on 27<sup>th</sup> March 2011.

Here are some headline statistics for Harrow based on a quick analysis of Harrow's ranking within the national ranking of all 348 local authorities, which include: London boroughs, unitary authorities and districts in England and Wales. Generally Harrow's position has been selected where it appears in the top or bottom ten ranked local authorities.

There is much more analysis to be undertaken in due course and many of the familiar census topics (for example: general health, car availability, provision of unpaid care, qualifications, economic activity, occupation and tenure) may not appear in this paper. This is largely due to the fact that Harrow does not feature in the headline rankings for these topics, but this information will be reported at a later date. Other papers will also look at Harrow's rankings specifically within London, but this information can be viewed on the Greater London Authority's (GLA) Datastore (see Further Information).

#### **Ethnic Group (Table KS201EW)**

- Fourth lowest ranking of residents in England & Wales who are White: English/Welsh/Scottish/Northern Irish/British (30.9%)
- Sixth highest ranking of residents who are White-Irish (3.1%)
- Second highest ranking of residents of Indian origin (26.4%), after Leicester
- **Highest ranking of residents who are Other Asian (11.3%)**
- Eighth highest ranking of Arabs (1.6%)

#### **Household language (Table KS206EW)**

- Ninth lowest ranking where all people aged 16 and over in household have English as a main language (English or Welsh in Wales) (67.0%)
- Seventh highest ranking where at least one but not all people aged 16 and over in household have English as a main language (English or Welsh in Wales) (13.5%)
- Seventh highest ranking where no people aged 16 and over in household but at least one person aged 3 to 15 has English as a main language (English or Welsh in Wales) (3.6%)
- Tenth highest ranking where No people in household have English as a main language (English or Welsh in Wales) (15.9%)

- Highest percentage of Hindus in England & Wales (25.3%)
- Second lowest ranking of residents with No Religion (9.6%), after Newham
- Fifth lowest percentage of Christians (37.3%) - ranked 344/348
- Sixth highest percentage of residents of Jewish faith (4.4%)
- Highest percentage of residents with Other Religions (2.5%)
  - Ranked sixth for religion = Brahma Kumari
  - Ranked first for religion = Jain
  - Ranked third lowest for religion = Pagan (346/348)
  - Ranked third lowest for religion = Spiritualist (346/348)
  - Ranked first for religion = Unification Church
  - Ranked second for religion = Zoroastrian
  - Ranked sixth lowest for no religion = Jedi Knight (343/348)

### Year of Arrival in UK (Table QS801EW)

- Third highest percentage of residents (born outside the UK) and who arrived in the UK between 1961 and 1970 (4.5% of all residents)
- Highest percentage of residents (born outside the UK) and who arrived in the UK between 1971 and 1980 (7.1% of all residents)
- Sixth highest percentage of residents (born outside the UK) and who arrived in the UK between 1981 and 1990 (4.9% of all residents)

### Passports Held (Table KS205EW)

- Sixth lowest ranking of residents in England & Wales who do not hold a passport (5.3%) i.e. 94.7% of residents hold a passport (6<sup>th</sup> highest ranking)
- Sixth highest ranking of residents who hold a Republic of Ireland passport (2.6%)
- Eighth highest ranking of residents who hold a passport from a Middle Eastern or Asian country (7.5%)

### Age of Arrival in UK (Table QS802EW)

Based on those residents not born in the UK

- Fourth highest ranking of 0-4 year olds (4% of all residents)
- Third highest ranking of 5-7 year olds (2% of all residents)
- Second highest ranking of 8-9 year olds (1.4% of all residents)

### National Identity (Table KS202EW)

- Highest ranking of residents with British only identity (41.6%)
- Ninth lowest ranking of residents with British and any other identity (6.5%)
- Lowest ranking of residents with No British identity (51.8%)
- Sixth highest ranking of residents with Irish only identity (2.2%)
- Sixth lowest ranking of residents with No Irish identity (97.6%)

### Country of Birth (Tables KS204EW & QS203EW)

- Sixth lowest ranking of residents born in the UK (55.2%)
- Ninth highest ranking of residents born in United Kingdom not otherwise specified (0.04%)
- Seventh highest ranking of residents born in Ireland (2.1%)
- Fourth highest ranking of residents born in Other countries (35.4%)
  - Ranked third lowest for country of birth = Europe (total) (65.5% of all residents)
  - Ranked fourth for country of birth = UK not specified
  - Ranked tenth lowest for country of birth = Guernsey
  - Ranked seventh for country of birth = Ireland (2.1% of all residents)
  - Ranked first for country of birth = Romania (2% of all residents)
  - Ranked second for country of birth = Africa: Total (11.7% of all residents)

- Ranked second for country of birth = Africa: South and Eastern Africa: Other South and Eastern Africa (3.4% of all residents)
- Ranked third for country of birth = Africa: Africa not otherwise specified
- Ranked sixth for country of birth = Middle East and Asia: Total
- Ranked tenth for country of birth = Middle East and Asia: Middle East: Other Middle East
- Ranked sixth for country of birth = Middle East and Asia: Southern Asia: Total
- Ranked fourth for country of birth = India (9% of all residents)
- Ranked first for country of birth = Sri Lanka (4.3% of all residents)
- Ranked fifth for country of birth = Middle East and Asia: Southern Asia: Other Southern Asia

### Dwellings, household spaces and accommodation type (Table 401EW)

- 86,524 dwellings in Harrow
  - 11.8% detached houses/bungalows
  - 39% semi-detached houses/bungalows
  - 18.5% terraced houses/bungalows
  - 22.7% flat, maisonette or apartment: purpose-built block of flats or tenement
  - 6.3% flat, maisonette or apartment: part of a converted or shared house (including bed-sits)
  - 1.7% flat, maisonette or apartment: in a commercial building
  - 0.02% caravan or other mobile or temporary structure

### **Household composition (Table KS105EW)**

- Ranked second lowest in England & Wales, after Hart, for one-person households (22.6% of households)
- Ranked ninth lowest in England & Wales, for other one-person households (excluding households with one-person aged 65+), 11.9% of households
- Ranked first for one family only households: Married or same-sex civil partnership couple: All children non-dependent (8.8% of all households)
- Ranked last for one family only households: Cohabiting couple: No children (2.6% of all households)
- Ranked fifth last for one family only households: Cohabiting couple: Dependent children (1.7% of all households)
- Ranked fifth for Other household types: With dependent children (6.9% of all households)

### **Living arrangements (Table KS104EW)**

- Lowest ranking of residents who are living in a couple: Cohabiting (5.7%)
- Lowest ranking of residents who are not living in a couple: Separated (but still legally married or still legally in a same-sex civil partnership) (4.5%)

### **Marital and civil partnership status (Table KS103EW)**

- Lowest ranking of residents who are divorced or formerly in a same-sex civil partnership which is now legally dissolved (5.4%)

### **Adults not in employment and dependent children and persons with long-term health problem or disability for all households (Table KS106EW)**

- Sixth highest ranking of dependent children in household: All ages (36.4%)
