# 2011 CENSUS SECOND RELEASE: HARROW BOROUGH PROFILE (PART 1)



On 11<sup>th</sup> December 2012 the Office for National Statistics (ONS) published Key Statistics and Quick Statistics for local authorities in England and Wales from the 2011 Census. This release marks the beginning of the release of detailed information about the characteristics of the people living in England and Wales on 27<sup>th</sup> March 2011.

In this paper you will find summary tables for Harrow based on the recently published Key and Quick Statistics tables, together with comparative data from the 2001 Census, where possible. In addition Harrow's ranks, both national and within London, are also shown for each of the indicators. The first part of the paper draws out a large number of key facts for Harrow, based on the accompanying tables in Appendix A. See 2011 Census Briefing Note 5 which also contains some headline statistics for Harrow, based on these datasets.

Some of the categories included in the published Key Statistics and Quick Statistics tables have changed between the two censuses, so direct comparisons are not always possible. For example, new tables have been introduced such as 'National Identity', 'Passports Held' and 'Household Language', while new categories such as 'Same-sex Civil Partnership' and a detailed breakdown of ethnic groups have also been included in 2011. Some of these categories are broadly comparable, so where this is the case comparisons have been included with explanatory notes.

The tables included in this paper form Part 1 of the Harrow Borough Profile which will be updated with the release of further data by the ONS.

# KEY FACTS FOR HARROW, FROM THE 2011 CENSUS SECOND RELEASE (11<sup>TH</sup> DECEMBER 2012)

Note: Nationally refers to England & Wales, with 348 local authorities, including London Boroughs, unitary authorities and districts.

Figures have largely been rounded to the nearest ten

### **Usual Resident Population**

• Harrow has a usual resident population of 239,056, 32,242 (15.6%) higher than the 2001 Census. The increase is higher than the national increase of 7.9 per cent and London's, at 14 per cent.

- 49.4 per cent of residents are males and 50.6 per cent are females, almost matching the national profile. In Harrow, the overall percentage of males has increased since 2001. The 2001 census showed that there were 7,000 more men than women in Harrow; this gap has now narrowed to just 3,000.
- There are over 1,000 (33.6%) more school children or students who live away from home during term-time, compared to 2001. With 4,250 'students' living away, Harrow is ranked 4<sup>th</sup> in London and 15<sup>th</sup> nationally.

### **Population Density**

- Harrow is one of the more densely populated of all local and unitary authorities in England, ranked 23rd out of 326 local authorities in England; where 1<sup>st</sup> is the most densely populated area. Harrow is ranked 21<sup>st</sup> in London.
- The average density in Harrow is 47.4 persons per hectare (pph), with higher rates in most wards to the south of the borough (the exception is Harrow on the Hill)
- Nationally the average density is 3.7 pph and London's overall density is 52 pph
- Wealdstone is the borough's most densely populated ward, with an average density of 96 persons per hectare, more then twice the borough average
- The six LSOAs showing the highest density changes all coincide with areas
  where there have been significant amounts of new development over the past
  decade i.e. the redevelopment of RAF Stanmore Park; Stanmore Place in
  Honeypot Lane; Wealdstone and Harrow town centres; and housing
  developments on Northolt Road and off Stanley Road in South Harrow.
- Over the decade Harrow's overall population density has increased by 6.4 persons per hectare

### **Age Structure**

- Looking at the borough's population in three broad age groups, 0-15 (children), 16-64 (working age) and 65+ (older people) there is little change in the proportions of these groups over the decade:
  0-15: 48,060, 20.1% (20.15% in 2001) 18.8% nationally, 19.8% London 16-64: 157,330, 65.8% (65.36% in 2001) 64.6% nationally, 69% London 65+: 33,670, 14.1% (14.47% in 2001) 16.6% nationally, 11.1% London
- Over the decade the population of Harrow's 0-15 group increased by 15.3 per cent; the 16-64 group increased by 16.4 per cent; and the population of the 65+ age group increased by 12.5 per cent
- Some of Harrow's population groups increased at far higher rates: children aged 0-4 increased by 32.4 per cent (3,900); the 20-24 age group increased by 23.5 per cent (3,050); the 25-29 age group by 23 per cent (3,620); and the 60-64 age group increased by 27.3 per cent (2,580)
- Harrow is ranked high in London for the proportion of: young people aged 10-14 (9<sup>th</sup>); 15 year olds (8<sup>th</sup>) and 16-17 year olds (3<sup>rd</sup>). Similarly for older people Harrow's ranks within London are: 65-74 years olds (5<sup>th</sup>); 75-84 year olds (5<sup>th</sup>); 85-89 year olds (7<sup>th</sup>) and aged 90+ (8<sup>th</sup>).
- The median age in Harrow is 36 years, younger than the national median age of 39 years, but older than London's median age of 33

### **Marital and Civil Partnership Status**

- Harrow has a very high percentage of married couples. 53.7 per cent of residents (aged 16+) are in a marriage, above the national level of 46.6 per cent, and ranks Harrow 1<sup>st</sup> in London. There was a 25 per cent increase in the number of married people living in Harrow over the decade.
- Correspondingly the borough has lower levels of people with other marital and civil partnership status
- Harrow is ranked last (33<sup>rd</sup>) in London for single people never married or registered in a same-sex civil partnership; 31<sup>st</sup> for people living in a registered same-sex civil partnership; 31<sup>st</sup> for separated; last for divorced or formerly in a same-sex civil partnership which is now legally dissolved; last for cohabiting couples

### **Household Composition**

- There was a 6.5 per cent (5,150) increase in the number of households in Harrow between 2001 and 2011, from 79,112 in 2001 to 84,268 in 2011
- Greenhill ward has seen the biggest increase in the number of households over the decade with 880 additional households (+21.6%), followed by Marlborough ward (670 households, +18.3%) and Canons ward (590 households, +13.9%)
- Harrow has the second lowest proportion of one-person households nationally, with 22.6 per cent of households being one-person (26.2% in 2001). The national average rate is 26 per cent.
- 10.7 per cent of Harrow's households are comprised of one-person aged 65 and over living alone, compared to 8.2 per cent nationally
- 36.3 per cent of households in Harrow have dependent children (above the national level of 29.1%), with Harrow ranked 1<sup>st</sup> in London for married couples with dependent children. Included within this general category of households with dependent children are Other households with dependent children (eg extended families), accounting for 7 per cent of all of Harrow's households, ranking Harrow 4<sup>th</sup> in London.

### Adults not in Employment and Dependent Children and Persons with Longterm Health Problem or Disability for all Households

- In 3,675 (4.4%) of Harrow's households there are no adults in employment, and with dependent children, ranking Harrow 24<sup>th</sup> in London, but in the top third nationally. This is a 3.5 per cent (130) fall compared to ten years previously. Nationally the level is just below Harrow's rate, at 4.2 per cent.
- 22 per cent (18,790) of households are comprised of adults not in employment, but no dependent children, down from 26 per cent (20,610) in 2001
- In 6 per cent (5,040) of Harrow's households one person has a limiting long-term health problem or disability and there are dependent children. This gives Harrow a 6<sup>th</sup> place ranking in London and 20<sup>th</sup> nationally, and is a higher level than the national rate of 4.7 per cent.

### **Lone Parents with Dependent Children**

- A 25.3 per cent increase over the decade, from 4,410 to 5,530
- 43.5 per cent of lone parents are not in employment, ranking Harrow 73<sup>rd</sup> nationally, but 26<sup>th</sup> in London. Nationally the level is 40.6 per cent.
- 92 per cent of Harrow's lone parents are female and 8 per cent are male. In 2001 9 per cent of lone parents were male.

### **Ethnic Group**

- 30.9 per cent (73,830) of Harrow's residents are White British, ranking Harrow fourth lowest nationally. This population group has fallen by 28.5 per cent in Harrow over the decade. The national level for this group is 80.5 per cent.
- The GLA's 2011 Census Ethnic Diversity Indices<sup>1</sup> show that Harrow is ranked 7<sup>th</sup> nationally for ethnic diversity (based on the 18 ethnic group classification), with a score of 5.27. Boroughs ranked higher are Newham (9.27), Brent (8.68), Ealing (6.44), Redbridge (5.69), Waltham Forest (5.61) and Hackney (5.44). Diversity indices measure the number of different/distinct groups present in the population and the sizes of these distinct groups relative to each other.
- Harrow's Indian group is the borough's largest minority ethnic group, with a population of 63,050 (26.4%), ranking Harrow 2<sup>nd</sup> nationally, after Leicester. In 2001 21.9 per cent of Harrow's residents were of Indian origin, showing a 39.2 per cent increase since 2001.
- Other Asian groups account for 11.3 per cent of Harrow's residents, with a top ranking nationally. Sri Lankans are the largest population group in this category in Harrow, but Afghans and residents from Nepal will also be recorded here.
- 8.2 per cent of Harrow's residents are categorised in the Other White group, the second largest ethnic grouping nationally, with 4.4 per cent of the total population. This group comprises people from a large variety of backgrounds.
- The Other Black category has shown the biggest percentage increase (369%) in Harrow since 2001, rising from 930 in 2001 to 4,370 (1.8%) in 2011. This may partly be due to larger numbers of residents using this 'write-in' box in response to this question, rather than simply ticking the African or Caribbean options. Over 1,000 Somali/Somalilanders used this option and the number of people who wrote 'Black-British' increased from 730 to 1,920 in 2011.
- Write-in answers showed that: 1.8 per cent (4,200) of Harrow's residents are Afghans (3<sup>rd</sup> highest ranking nationally); 1.5 per cent (3,550) are Polish (47<sup>th</sup> ranking nationally); 1.9 per cent (4,480) are Other Eastern Europeans (ranked 5<sup>th</sup> nationally); 12,410 (5.2%) are Sri Lankans (ranked 1<sup>st</sup> nationally); and 2,850 (1.2%) are Tamils (ranked 1<sup>st</sup> nationally). 1,010 (0.5%) residents wrote in Somalia or Somaliland, but other residents from these countries may have simply ticked Black-African as their ethnic group preference.
- 57.2 per cent (48,160) of all households are comprised of residents of the same ethnic group, the 3<sup>rd</sup> highest ranking in London and just below the national level of 61.1 per cent

 9.4 per cent (7,930) of Harrow's households are made up of partnerships of different ethnic groups, a 20 per cent increase since 2001

### **National Identity**

This was a new question in the 2011 Census and respondents were able to tick all categories that applied (English, Welsh, Scottish, Northern Irish, British, and a 'write-in' answer box)

- Harrow is ranked top nationally for the highest proportion of residents who just considered themselves to be British, at 41.6 per cent (99,540). The overall national level is 19.1 per cent.
- 68,770 (28.8%) of residents only ticked English as their national identity
- 21.5 per cent (51,515) solely used the 'write-in' box to state another national identity only, above the national average of 8.1 per cent and ranking Harrow 22<sup>nd</sup> nationally

### **Country of Birth**

- 55.2 per cent (132,010) of Harrow's residents were born in the UK, the 6<sup>th</sup> lowest ranking nationally. In 2001 the corresponding percentage was 67 per cent. Nationally the 2011 Census showed that 86.6 per cent of usual residents were born in the UK.
- European Union (EU) Accession countries (April 2001 to March 2011) are the country of birth for 11,265 (4.7%) residents, the 18<sup>th</sup> highest ranking nationally and more than twice the national average of 2 per cent
- Other EU countries (including Ireland) are the birthplace of a further 4.7 per cent (11,130) of residents, twice the national average of 2.3 per cent
- 35.4 per cent (84,655) of residents were born elsewhere the 4<sup>th</sup> highest ranking nationally and nearly four times the national average of 9 per cent

### The more detailed outputs show:

- An 18.8 per cent fall in the number of residents born in Ireland, but Harrow is ranked 7<sup>th</sup> nationally for Ireland as a country of birth (4,950 residents, 2.1%)
- Harrow is ranked top in the country for the percentage of residents born in Romania (4,780, 2%), compared to 91 people in 2001
- Big increases in the number of residents born in Poland, Lithuania and other EU Accession countries generally
- Harrow is ranked second nationally for residents who were born in Africa generally (27,900, 11.7%) and ranked first nationally for the percentage of residents born in Kenya (11,710, 4.9%) and South and Eastern Africa generally
- 10,390 (4.3%) residents were born in Sri Lanka, the highest ranking nationally, and a 98 per cent increase since 2001

### **Year of Arrival in UK**

 44.7 per cent (107,050) of Harrow's residents were born outside the United Kingdom

- 41 per cent (43,820) of the residents who were born outside the UK, and living in Harrow, arrived in the UK over the past decade. Nationally, and in London overall, the corresponding rate is higher, at 50 per cent and 49.2 per cent respectively.
- The remaining 59 per cent of Harrow's migrant residents settled in the UK at more regular intervals over the previous four decades, with: 10 per cent arriving between 1961 and 1970; 16 per cent between 1971 and 1980; 11 per cent between 1981 and 1990; and 18 per cent between 1991 and 2000
- Overall Harrow is ranked 2<sup>nd</sup> nationally for the percentage of residents who arrived in the UK over ten years ago (26.8% of all residents, 64,105). Harrow ranks 1<sup>st</sup> nationally for the percentage of residents who arrived in the UK between 1971 and 1980 (17,010, 7.1% of all residents), and 3<sup>rd</sup> for the percentage who arrived between 1961 and 1970 (10,690, 4.5% of all residents).

### Age of Arrival in UK

- Nearly 55 per cent (58,370) of Harrow's migrant resident population were aged between 20 and 44 when they arrived in the UK, the same as the national level
- Over a quarter (26.6%, 28,490) of migrant residents were children (aged 0-15) when they arrived in the UK, below the national level of 28.7 per cent
- Only 1,180 (1.1%) of Harrow's residents were aged 65 and over when they came to the UK, above the national proportion of 0.6 per cent
- In the national rankings Harrow is ranked in the top ten of all local authorities based on the percentage of residents who were aged between 0 and 19; and from ages 45 to 89 when they arrived in the UK

### **Passports Held**

- 94.7 per cent of Harrow's residents hold a passport, the 6<sup>th</sup> highest ranking nationally
- UK passports are held by 74.6 per cent of residents, the 11<sup>th</sup> highest ranking in London

### **Household Language**

- In a high percentage of Harrow's households English is not the main language
- English is spoken as a main language by all people aged 16 and over in 67 per cent of Harrow's households the 9<sup>th</sup> lowest ranking nationally and considerably lower than the national average of 91.2 per cent
- In 13.5 per cent (11,380) of Harrow's households at least one-person, but not all (aged 16+), speaks English as a main language. This percentage is the 7<sup>th</sup> highest ranking nationally.
- In 3.6 per cent (3,030) of households no adults use English as their main language, but English is the main language of at least one-person aged 3-15, the 7<sup>th</sup> highest ranking nationally

 In 15.9 per cent (13,415) of households English is not the main language of any household occupants, the 10<sup>th</sup> highest ranking nationally and much higher than the national level of 4.3 per cent

### Religion

This question was a voluntary question in the 2011 Census

- Religious affiliation is very high in Harrow, with Harrow having the 2<sup>nd</sup> lowest number of residents who stated that they have no religion, after Newham. 9.6 per cent (22,870) Harrow's of respondents stated that they have no religion, compared to 24.7 per cent nationally.
- Only 6.2 per cent of residents didn't answer this question the lowest level in London
- The GLA's Religious Diversity Indices show that Harrow is London's 2<sup>nd</sup> most religiously diverse boroughs, after Redbridge
- Christianity was identified as Harrow's most common religion with 37.3 per cent of followers (59.3% nationally), but overall there was an 8.8 per cent fall in followers since 2001. Harrow is ranked 5<sup>th</sup> lowest nationally for this indicator.
- 25.3 per cent (60,410) of Harrow's residents are Hindus, a 49 per cent increase since 2001. This is Harrow's second most common religion and the highest national ranking.
- The number of residents of Jewish faith fell by 20 per cent between censuses, but with 10,530 (4.4%) followers, Harrow is ranked 6<sup>th</sup> nationally and 4<sup>th</sup> in London
- Harrow is ranked first for people with Other Religions, with 5,945 people (2.5%), the majority being Jains (5,190) and the highest ranking nationally
- There has been a 100 per cent increase in the number of Muslims in Harrow, from 14,915 in 2001 to 29,880 (12.5%) in 2011. Islam is London's second most common religion and Harrow's third. Nationally, 4.8 per cent of people follow Islam, the second biggest group.
- Harrow has the 2<sup>nd</sup> highest ranking of Zoroastrians, after Barnet

### **Health & Unpaid Care**

- The proportion of residents who regard their general health as good is 83.6 per cent, a similar overall level to 2001 and above the national average of 81.2 per cent. When Harrow's population increase is taken into account this percentage increased by 15.8 per cent. On this measure Harrow is ranked 18<sup>th</sup> in London.
- Conversely 16.4 per cent (39,260) of residents do not consider their health to be good, an overall increase of 14.4 per cent since 2001 and 16<sup>th</sup> ranking in London
- Very bad health was reported by 1.1 per cent of residents (1.3% nationally), accounting for 2,640 people and ranking Harrow 23<sup>rd</sup> in London
- 14.6 per cent of residents (34,850) have a limiting long-term illness or disability which limits their day-to-day activities, below the national average of 17.9 per cent and an increase of 13.2 per cent since 2001. 47 per cent of these residents' daily activities are limited a lot, ranking Harrow 17<sup>th</sup> in London.

- 10.3 per cent (24,620) of Harrow's residents provide unpaid care to others, which is the same as the national average. However, this is the 2<sup>nd</sup> highest level within London.
- 1.7 per cent (3,950) of residents provide between 20-49 hours of unpaid care per week, the 2<sup>nd</sup> highest level in London and ranked 55<sup>th</sup> nationally

### **Dwellings, Household Spaces and Accommodation Type**

- The 2011 Census recorded 86,524 separate dwellings in Harrow
- In total there are 86,667 household spaces more household spaces than dwellings, as there may be more than one household space at the same address
- Over two-thirds (69.3%, 60,130) of residential units are houses, below the national average of 78 per cent, but the 6<sup>th</sup> highest level in London. Although the number of houses in the borough has increased by 1,550 over the decade, in 2001 72.4 per cent of Harrow's housing units were houses.
- There has been a 21.6 per cent increase in the number of purpose-built flats since 2001, with nearly 3,500 new units since 2001

#### **Tenure**

- Home ownership is higher in Harrow (66.2%) than both nationally (64.3%) and in London (49.5%)
- Harrow is ranked 4<sup>th</sup> in London for outright home ownership and 9<sup>th</sup> for households buying with a mortgage or loan
- Over the decade, home ownership (owned outright; owned with mortgage or loan; and shared ownership) has fallen in Harrow by 6 per cent. Home ownership fell in London by 5.1 per cent, but rose by 0.8 per cent nationally.
- In Harrow, the percentage of people who own their own home outright rose by 3.1 per cent; shared ownership rose by 15.3 per cent, but there was a 13.6 per cent fall in households buying with a mortgage or loan
- Harrow's largest tenure change was in the private rented sector the number
  of households living in private rented accommodated more than doubled
  (+106%) over the decade. 17,165 (20.4%) households now rent their home
  from a private landlord or letting agency (compared to around 8,300 (10.5%) in
  2001). This is just below London's level of 23.7 per cent, but above the
  national level of 15.3 per cent.
- The 2011 Census showed that only 125 more households were living in social housing (local authority and housing association/registered social landlord [RSL]) compared to ten years ago. There was a 7 per cent fall in households renting from the local authority, but a 16 per cent increase in households renting from an RSL.

Note: Many researchers believe that the census tenure question has always been poorly answered, as a large number of people living in rented accommodation, in particular, are uncertain about who their landlord is.

### **Rooms, Bedrooms and Central Heating**

- 98.3 per cent of Harrow's households have central heating in their homes, above both the national average of 97.3 per cent and London's level of 96.8 per cent, and ranking Harrow 1<sup>st</sup> in London
- 16.3 per cent (13,760) of Harrow's households are considered to be 'overcrowded', on the basis that they have one fewer room than required. This gives Harrow a ranking of 25<sup>th</sup> in London and 28<sup>th</sup> nationally. 'Overcrowding' based on bedrooms, shows that 8,850 (10.5%) households have one fewer bedroom than required, giving Harrow a 20<sup>th</sup> ranking in London and 22<sup>nd</sup> nationally.
- On average Harrow's households have 5.3 rooms and 2.8 bedrooms, ranking Harrow 2<sup>nd</sup> in London on both measures. Nationally households have an average of 5.4 rooms and 2.7 bedrooms.

### **Average Household Size**

- Harrow's average household size (AHS) increased from 2.6 in 2001 to 2.8 in 2011
- Harrow has the 2<sup>nd</sup> highest AHS of all local authorities nationally, after Newham
- On a ward basis the AHS varies from a low of 2.4 in Pinner ward to a high of 3.3 in Kenton West and Queensbury wards

### Car or Van Availability

- There are nearly 6,000 (6.3%) more cars (or vans) owned or available to Harrow's households since 2001
- Nationally 74.3 per cent of households have at least one car, Harrow's percentage is higher, at 76.4 per cent, but lower than the 2001 level of 77.3 per cent
- Nearly a third (27,440) of Harrow's households have two or more cars, a similar level to 2001
- Harrow's rankings within London for car ownership are high 12<sup>th</sup> for one car;
   2<sup>nd</sup> for two cars; 3<sup>rd</sup> for three cars and 6<sup>th</sup> for four or more cars

#### **Communal Establishments**

- 146 communal establishments were recorded in the borough in 2011, 24 per cent more than in 2001 (118)
- 450 (27%) more usual residents were recorded as living in Harrow's communal establishments in 2011. However, looking at the 2001 Census it is clear that Harrow School was under enumerated in the 2001 Census with only around 94 pupils (18-19 year olds) being recorded in the 2001 Census, considerably lower than the known number of pupils boarding at the school (over 800). When this is taken into account it appears that there may be fewer residents recorded as living in communal establishments in Harrow in 2011, compared to 2001.

 Nearly 58 per cent of Harrow's residents who live in communal establishments are in medical are care establishments, the remaining 42 per cent can be attributed to Harrow School

### **Qualifications and Students**

2011 and 2001 Census data on qualifications is not directly comparable. 2001 counts are based on people aged 16-74, whereas 2011 counts are for people aged 16 and over.

- A high percentage of Harrow's residents have degree level qualifications.
   Nearly 37 per cent (70,220) of residents aged 16 to 75, have the equivalent of a degree, ranking Harrow 38<sup>th</sup> nationally and 19<sup>th</sup> in London. Nationally this level is 27 per cent.
- In addition, 10.7 per cent (20,340) of Harrow's residents hold 'Other' qualifications, which include foreign qualifications. This level is the 12<sup>th</sup> highest level nationally and considerably higher than the national level of 5.7 per cent.
- 16.8 per cent (32,000) of residents aged 16 to 74 have no qualifications, ranking Harrow 307<sup>th</sup> nationally and 20<sup>th</sup> in London. The national level is 22.7 per cent.
- There are 12,970 students (aged 18+) living in Harrow and around a third of these are also in employment. This is approximately a 56 per cent increase since 2001.

### **Economic Activity**

These outputs are based on residents who are aged 16 to 74

- 70.6 per cent (174,750) of Harrow's residents are economically active (in work or seeking work), 19.7 per cent higher than in 2001. This is just below London's level of 71.7 per cent, but above the national rate of 69.7 per cent.
- 37.5 per cent (65,490) of Harrow's residents work full-time, below the 2001 level of 42.3 per cent
- Within London, Harrow has a high ranking for part-time workers (7<sup>th</sup>), with 12.3 per cent (21,420) of residents, below the national average of 13.7 per cent, but above London's level of 10.9 per cent. This shows a 40 per cent increase in Harrow's part-time workers since 2001.
- Harrow has a high number of self-employed workers (22,120, 12.7%), with 8<sup>th</sup> ranking in London and a level above the national (9.7%) and London (11.7%) averages. Harrow's level is 49 per cent higher than in 2001.
- 4.5 per cent (7,850) residents stated that they were unemployed; almost the same as the national level (4.4%) and below London's rate of 5.2 per cent. This shows a 71 per cent increase in Harrow since 2001.
- The largest grouping (18,190) amongst Harrow's economically inactive residents are retired people, accounting for over a third (35.4%) of this group and the 4<sup>th</sup> highest level in London. There has been a 7.5 per cent increase in the number of retired people in Harrow since 2001.
- Students are the next largest economically inactive group, 26.1 per cent of the economically inactive group, and showing a 41.6 per cent increase in numbers since 2001

#### **Hours Worked**

- The majority (59.2%) of Harrow's workers work between 31 and 48 hours per week, down from 62.6 per cent in 2001, but an increase in numbers due to population growth
- There has been a 2 per cent fall in the number of Harrow's workers working over 49 hours a week, down to 12.8 per cent, below the national level of 13.2 per cent and the London average of 15.9 per cent
- 28 per cent work 30 hours or less per week (up from 22.2% in 2001), above the London average (25.7%), but below the national level of 29.1 per cent
- There has been a large increase in the number of Harrow's male workers who
  work part-time. 11,120 worked 30 hours or less in 2011, compared to 5,440 in
  2001, a 104 per cent increase. The increase in the numbers of women who
  worked part-time was just 28 per cent.

### **Industry**

New industry codings in 2011, based on the 2007 Standard Industrial Classification do not currently allow comparisons with the 2001 Census outputs for Industry of Employment.

- The highest proportion (17.5%, 19,930) of Harrow's workers (aged 16 to 74) are employed in wholesale & retail trade, repair of motor vehicles activities.
  Harrow is ranked 1<sup>st</sup> in London for this industry group.
- 11 per cent (12,430) of residents work in jobs associated with human health and social work activities, the second largest industry group for Harrow's workers
- Nationally Harrow is ranked in the top 10 per cent of local authorities for workers who are employed in professional, scientific and technical activities (34<sup>th</sup>) and in the top quartile for: wholesale & retail trade, repair of motor vehicles (76<sup>th</sup>); transport and storage (88<sup>th</sup>); information and communication (48<sup>th</sup>); financial and insurance activities (46<sup>th</sup>); and real estate activities (40<sup>th</sup>)
- The highest proportion of males (18.4%) work in wholesale & retail trade, repair of motor vehicles related activities, whilst the highest proportion of Harrow's females are employed in human health and social work activities (17.6%)

### **Occupation**

The 2011 Census uses the 2010 Standard Occupational Classification for coding occupation. It includes all people aged 16 to 74 who were in employment at the time of the 2011 Census, or in the week before.

- Professional occupations constitute Harrow's largest occupation group, with 23 per cent (26,450) of workers. This group ranks Harrow 29<sup>th</sup> nationally and 17<sup>th</sup> in London. There has been a 71 per cent increase in the number of Harrow's workers in these occupations since 2001. This is the largest occupation group both nationally and in London, with 17.4 per cent and 22.5 per cent of workers respectively. Professional workers form the largest occupational group for both men and women living in Harrow.
- Administrative and secretarial occupations form Harrow's second largest occupation category, with 13.6 per cent (15,460) of workers, but with

- diminished numbers since 2001. This level is above both the national (11.4%) and London levels (11.7%). This was Harrow's largest sector in 2001, with 17,610 (18%) workers and ranks Harrow in the top decile of local authorities, with a ranking of 26<sup>th</sup>.
- Caring, leisure and other service occupations saw the second largest percentage increase amongst Harrow's workers over the decade, with a 60 per cent increase, from 5,210 to 8,360 (7.3% of workers). Harrow's level is below the national level of 9.4 per cent and London's level of 7.9 per cent.

### **National Statistics Socio-Economic Classification**

The National Statistics Socio-economic Classification (NS-SeC) provides an indication of socio-economic position based on occupation. It is an Office for National Statistics standard classification. All people aged 16 to 74 are included in this classification.

- 14 per cent of Harrow's residents are classified in the NS-SeC category 1
  (higher managerial, administrative and professional occupations). This is
  above both the national level of 10.3 per cent and the London level of 13.2 per
  cent. Nearly twice as many of Harrow's men, compared to women, fall within
  this category.
- Harrow's largest NS-SeC category is 2 (lower managerial, administrative and professional occupations) with 21.3 per cent (37,270) of residents, similar to the national level of 20.8 per cent, but below London's level of 23.1 per cent. This is also the largest category for England & Wales, as well as for London.
- In percentage terms the biggest change over the decade, for Harrow (for both men and women), was in the category long-term unemployed, which increased by 132 per cent, from 1,265 to 2,940. 1.7 per cent of residents were recorded in this category, the same as the national level, but below London's level of 2 per cent.
- For men there was a significant increase in the number who have never worked, with an 88 per cent increase over the decade, rising from 1,445 to 2,720
- For women the increase in the number of small employers and own account workers (NS-SeC 4) was notable, with numbers increasing from 2,700 to 5,520 (+104%)

#### Mean age

Mean age is calculated by dividing the sum of each person's age by the number of people. Ages are the age at last birthday (in whole years).

#### Median age

The median age is the middle value when all the ages are arranged in order from youngest to oldest. Ages used are the age at last birthday (in whole years).

#### Marital and civil partnership status

Marital and civil partnership status classifies an individual according to their legal marital or registered same-sex civil partnership status as at census day, 27 March 2011.

This topic is the equivalent of the 2001 Census topic 'Marital status', but has undergone significant revision to take account of the Civil Partnership Act which came into force on 5 December 2005.

Marital and civil partnership states include married/in a registered same-sex civil partnership, separated (but still legally married/in a registered same-sex civil partnership), divorced/formerly in a registered same-sex civil partnership or widowed/surviving same-sex civil partner.

Although the term 'single' is widely used to cover people in a number of states such as divorced or separated it is not a legally recognised status and was not an option on the census questionnaire. In census results the term 'single' is used to refer only to someone who has never been married or in a registered same-sex civil partnership, which were options on the census questionnaire.

#### Married or in a registered same-sex civil partnership

The classification for married has changed to incorporate same-sex civil partnership. Same-sex civil partnerships only became legal in 2005 and therefore was not a variable for the 2001 Census. Those in same-sex civil partnerships pre-2005 would previously have been classified as single.

The ONS consider 2001 and 2011 data for this table to be broadly comparable.

#### Living arrangements

The living arrangements variable is different to marital status. It combines information from both marital status and the relationship matrix. Therefore a person living as part of a 'cohabiting couple' could in fact be married (to someone else) but will not appear as married or separated in this classification.

#### Not living in a couple

A person not living in a couple can be classified married (or re-married) if they denote their marital status as married (or re-married) but have no spouse or partner resident in the household.

### National identity

A person's national identity is a self-determined assessment of their own identity with respect to the country or countries with which they feel an affiliation. This assessment of identity is not dependent on legal nationality or ethnic group.

The national identity question included six tick box responses - one for each of the four parts of the UK (English, Welsh, Scottish, Northern Irish), one for British, and one for 'Other' Where a person ticked 'Other' they were asked to write in the name of the country. People were asked to tick all options that they felt applied to them. This means that in results relating to national identity people may be classified with a single national identity or a combination of identities.

British identity excludes responses indicating an identity related to the British Virgin Islands and British Overseas Territories.

#### Country of birth

Country of birth is the country in which a person was born. The country of birth question included six tick box responses - one for each of the four parts of the UK, one for the Republic of Ireland, and one for 'Elsewhere'. Where a person ticked 'Elsewhere', they were asked to write in the current name of the country in which they were born. Responses are assigned codes based on the National Statistics Country Classification.

The grouping of countries within the classification is broadly regional, but takes into account the grouping of European Union (EU) countries. Countries in the EU are grouped into those that were EU members in March 2001, and those that became members (Accession countries) between April 2001 and March 2011 as part of the EU enlargement process.

When a person's written response to the country of birth question was a former country name, and the country that it relates to no longer exists and is not wholly contained within the geographic boundary of a current country, the response was coded to one of the additional categories contained in the 'Former country' grouping. For example, 'Czechoslovakia' was coded to 'Czechoslovakia not otherwise specified'.

Ireland now includes people who ticked the Republic of Ireland and those who wrote in "Island of Ireland" or Ireland (plus Ulster which spans both north and south) Northern Irel is those who recorded this ticked box.

'2001 Census data for "Other countries" compares 2011 Census Other EU: Accession countries, UK not otherwise specified and Other countries.

#### Long-term health problem or disability

A long-term health problem or disability that limits a person's day-to-day activities, and has lasted, or is expected to last, at least 12 months. This includes problems that are related to old age. People were asked to assess whether their daily activities were limited a lot or a little by such a health problem, or whether their daily activities were not limited at all.

#### General health

General health is a self-assessment of a person's general state of health. People were asked to assess whether their health was very good, good, fair, bad or very bad. This assessment is not based on a person's health over any specified period of time.

To allow a comparison with 2001, general health has been divided as 'good health' and 'not good health'. This has combined 2011 Census as 'very good health' and 'good health' together as 'good health' and 'fair health', 'bad health', and 'very bad health' as 'not good health'.

#### Provision of unpaid care

A person is a provider of unpaid care if they look after or give help or support to family members, friends, neighbours or others because of long-term physical or mental ill health or disability, or problems related to old age. This does not include any activities as part of paid employment. No distinction is made about whether any care that a person provides is within their own household or outside of the household, so no explicit link can be made about whether the care provided is for a person within the household who has poor general health or a long-term health problem or disability.

#### Working age

The 2011 Census defines working age as between 16 to 64 for both men and women. In 2001 the working age population was regarded as 16-64 inclusive for men and 16-59 inclusive for women.

#### Accommodation type

The type of accommodation used or available for use by an individual household. Examples include the whole of a terraced house, or a flat in a purpose-built block of flats.

#### Dwelling

A dwelling is a unit of accommodation in which all rooms - including the kitchen, bathroom and toilet - are behind a door that only that household can use.

A dwelling may comprise one or more household spaces (the accommodation used or available for use by an individual household).

A dwelling may be classified as shared or unshared. A dwelling is shared if:

- the household spaces it contains have the accommodation type 'part of a converted or shared house'
- not all of the rooms (including kitchen, bathroom and toilet, if any) are behind a door that only that household can use, and
- there is at least one other such household space at the same address with which it can be combined to form the shared dwelling.

Dwellings that do not meet these conditions are unshared dwellings.

#### Household

A household is defined as one person living alone, or a group of people (not necessarily related) living at the same address who share cooking facilities and share a living room or sitting room or dining area.

A household must contain at least one person whose place of usual residence is at the address. A group of short-term residents living together is not classified as a household, and neither is a group of people at an address where only visitors are staying.

#### Household space

A household space is the accommodation used or available for use by an individual household.

Household spaces are identified separately in census results as those with at least one usual resident, and those that do not have any usual residents.

A household space with no usual residents may still be used by short-term residents, visitors who were present on census night, or a combination of short-term residents and visitors.

Vacant household spaces and household spaces that are used as second addresses are also classified in census results as household spaces with no usual residents.

#### Occupancy Rating

Occupancy rating provides a measure of whether a household's accommodation is overcrowded or under occupied. There are two measures of occupancy rating, one based on the number of rooms in a household's accommodation, and one based on the number of bedrooms. The ages of the household members and their relationships to each other are used to derive the number of rooms/bedrooms they require, based on a standard formula. The number of rooms/bedrooms required is subtracted from the number of rooms/bedrooms in the household's accommodation to obtain the occupancy rating. An occupancy rating of -1 implies that a household has one fewer room/bedroom than required, whereas +1 implies that they have one more room/bedroom than the standard requirement.

#### Average household size

The average household size for an area is equal to the total number of usual residents living in households in that area divided by the total number of households in the area that have at least one usual resident.

#### Average number of rooms/bedrooms per household

The average number of rooms/bedrooms per household for any area is equal to the total number of rooms/bedrooms in households in the area divided by the number of households in the area.

#### Rooms

The definition of a room does not include bathrooms, toilets, halls or landings, or rooms that can only be used for storage. All other rooms, for example, kitchens, living rooms, bedrooms, utility rooms, studies and conservatories are counted.

If two rooms have been converted into one they are counted as one room. Rooms shared between a number of households, for example a shared kitchen, are not counted.

#### **Bedrooms**

A bedroom is defined as any room that was intended to be used as a bedroom when the property was built, or any room that has been permanently converted for use as a bedroom. It also includes all rooms intended for use as a bedroom even if not being used as a bedroom at the time of the Census.

Bedsits and studio flats are counted as having one bedroom.

#### Cars or vans

The number of cars or vans that are owned, or available for use, by one or more members of a household. This includes company cars and vans that are available for private use. It does not include motorbikes or scooters, or any cars or vans belonging to visitors.

The count of cars or vans in an area relates only to households. Cars or vans used by residents of communal establishments are not counted. Households with 10 or more cars or vans are counted as having only 10.

Responses indicating a number of cars or vans greater than 20 were treated as invalid and a value was imputed.

#### Country of birth

Country of birth is the country in which a person was born. The country of birth question included six tick box responses - one for each of the four parts of the UK, one for the Republic of Ireland, and one for 'Elsewhere'. Where a person ticked 'Elsewhere', they were asked to write in the current name of the country in which they were born. Responses are assigned codes based on the National Statistics Country Classification.

The grouping of countries within the classification is broadly regional, but takes into account the grouping of European Union (EU) countries. Countries in the EU are grouped into those that were EU members in March 2001, and those that became members (Accession countries) between April 2001 and March 2011 as part of the EU enlargement process.

When a person's written response to the country of birth question was a former country name, and the country that it relates to no longer exists and is not wholly contained within the geographic boundary of a current country, the response was coded to one of the additional categories contained in the 'Former country' grouping. For example, 'Czechoslovakia' was coded to 'Czechoslovakia not otherwise specified'.

Ireland now includes people who ticked the Republic of Ireland and those who wrote in "Island of Ireland" or Ireland (plus Ulster which spans both north and south) Northern Ireland is those recorded this ticked box.
