GENDER, AGE, RELIGION AND HEALTH, BY ETHNIC GROUP 2011 CENSUS THIRD RELEASE (3.1)

The Office for National Statistics (ONS) released over thirty detailed tables of 2011 Census statistics at Local Authority level and regional level on 16th May 2013. These are the first of the Detailed Characteristics tables which cross tabulates two or more topics.

This Briefing Note is the first to look at these Detailed Characteristics tables and looks at just four tables: Ethnic Group and Sex by Age (DC2101EW); Ethnic Group by Religion (DC2201EW); Ethnic Group by General Health (DC2301EW); and Disability by General Health, by Ethnic Group, by Sex, by Age (DC3201EW).

1. Ethnic Group by Sex (Table 1)

The broad ethnic group categories are: White; Mixed/multiple ethnic group; Asian/Asian British; Black/Black British; and Other ethnic group. For the 2011 Census there are 18 individual ethnic group categories (see Table 1).

- 50.6 per cent of Harrow's residents are females: 49.4 per cent are males.
- There is some variation by ethnic group with a higher proportion of males of: Pakistani ethnicity (52.5%) Arab ethnicity (53.6%); and Other Black ethnicity (51.4%).
- There are higher proportions of females who are: Black-Caribbean origin (55.8%); Black-African ethnicity (55%); Chinese (53.4%); and Gypsy or Irish Travellers (53.6%). The latter is Harrow's smallest minority ethnic group with just 181 residents in total.

2. Ethnic Group by Age (Table 2 & Figure 1)

Children aged 0 to 4

- In total 6.7 per cent (15,916) of Harrow's residents are children aged four and under. 81.6 per cent (12,991) of all children aged 0 to 4 in Harrow are from minority ethnic groups (all groups excluding White British). 44.8 per cent (7,134) of all Harrow's young children are of Asian/Asian British ethnic origin, the largest ethnic grouping.
- Looking at the 18 ethnic groups, in numerical terms the highest numbers of young children in Harrow are of Indian origin (3,691, 23.2% of all aged 0-4); White British (2,925, 18.4% of all aged 0-4); and Other Asian (2,502, 15.7% of all aged 0-4)

Children aged 5 to 15

- 13.4 per cent (32,142) of Harrow's residents are children aged 5 to 15. The make-up of children of this age is similar to the 0-4 age group, with children of Asian/Asian British accounting for 42.5 per cent (13,652) of this age group, the highest percentage by broad ethnic group. Overall 76.5 per cent of children aged 5 to 15 are from non-White British groups.
- 9,931 (23.5%) children of this age are White British, the largest individual group numerically, followed by Indian (6,918, 21.5%) and Other Asian (4,886, 15.2%)

Working Age Population aged 16 to 64

- 65.8 per cent (157,331) of all Harrow's usual residents fall within this working age category. Overall 71.9 per cent (93,437) of Harrow's residents of working age are from minority ethnic groups (all groups who are not White British).
- By broad ethnic group, the highest proportion of residents of working age are the Asian/Asian British group, with 45.6 per cent (71,817) of all residents, followed by the White group, with 40.6 per cent (63,894) of all residents aged 16 to 64
- Numerically residents of Indian origin account for the highest number and proportion of all residents of working age in Harrow, at 29 per cent (46,670). The White British group follows closely behind, with 28.1 per cent (44,189), then the Other Asian group, at 11.5 per cent (18,058). 9.5 per cent (14,908) of Harrow's residents of working age come from the White Other group.

Residents aged 65 and over

- 14.1 per cent (33,667) of Harrow's residents are aged 65 and over
- Of Harrow's 33,667 residents aged 65 and over, two-thirds are from the White groups
- 22,538 (56.9%) of all Harrow's residents aged 65 and over are White British, the largest individual group. The second largest group is the Indian group, making up with 20.1 per cent (6,772) of all residents aged 65 and above. Residents of Irish origin constitute the third largest group, at 5.8 per cent (1,937 residents).

White Group

- Harrow's White group (in particular the White British and the White Irish groups) has an older age profile compared to all the other broad ethnic groups. Overall the White group has the lowest percentage of children aged four and under, with only 4.6 per cent of residents of this age
- Amongst the individually identified ethnic groups the lowest percentage of young children (0-4) are of White Irish origin, accounting for just 2.7 per cent of all White Irish residents. In the White British group just 4 per cent of all residents are aged four and under.

- The Gypsy or Irish Traveller group has low numbers, with just 181 residents in total. However, the proportion of children aged 0 to 4 and 5 to 15 is high amongst this ethnic group, at 9.4 per cent and 33.1 per cent respectively, considerably higher than the borough averages (6.7% and 13.4%).
- In two of the White groups less than ten per cent of the overall population of these groups are children aged 5 to 15. These are the White Irish (6.8%) and Other White (9.3%) groups.
- The Other White group has the highest proportion of residents who are of working age (16 to 64), at 75.9 per cent, which is ten percentage points above the borough average of 65.8 per cent
- The White group has the highest percentage of residents of retirement age (65 and over), with 22.3 per cent of all White residents falling within this age range. Overall, 14.1 per of Harrow's residents are aged 65 and over.
- By individual ethnic group the White Irish and White British groups have the highest percentage of older residents, at 26.4 per cent and 26 per cent respectively

Mixed/multiple ethnic group

- 9,499 (4%) of Harrow's residents are from the Mixed/multiple ethnic group. This group has the youngest age profile of all the broad ethnic groups, with high percentages of children and the lowest percentage of residents aged 65 and over.
- Children aged 0 to 4 of Mixed race constitute 18.5 per cent of the total Mixed/multiple ethnic group population, the highest percentage of all the broad ethnic groups
- Groups with a high proportion of children aged 0 to 4 are: Mixed White/Asian (21.2%); Mixed White/Black Caribbean (14.8%); and Mixed White/Black African (14.1%)
- 30.9 per cent of the Mixed/multiple ethnic group population are aged 5 to 15, considerably higher than the borough average of 13.4 per cent. The Mixed White/Black Caribbean (33.4%) and Mixed White/Asian (32.8%) groups have the highest proportions.
- Only 47.2 per cent of residents from Mixed/multiple ethnic groups are of working age, the lowest level of all the broad ethnic groups in Harrow
- Just 3.4 per cent of residents of Mixed race are aged 65 and over, much lower than the borough level of 14.1 per cent. The Mixed White/Black African group has the lowest percentage of residents aged 65 and over, compared to all the other ethnic groups, at just 2 per cent.

Asian/Asian British

- Overall the age profile of Harrow's Asian/Asian British group is very similar to the borough average for the younger age groups, but is over represented at working age and under represented at age 65 and over
- The Indian and Chinese groups have older age profiles, compared to the Pakistani, Bangladeshi and Other Asian groups
- Seven per cent of residents of Asian/Asian British origin are aged four and under, just above the borough average of 6.7 per cent

- The Chinese group has low numbers of young children, just 3.7 per cent of all Chinese residents are of this age, and 9.7 per cent are aged 5 to 15 considerably lower than the borough averages
- 70.5 per cent of all residents in the Asian group are of working age, the highest level of the five broad ethnic group categories and above the borough's level of 65.8 per cent. The Chinese and Indian groups have the highest levels of working age residents, at 75.5 per cent and 72.4 per cent respectively.
- Nine per cent of Harrow's Asian/Asian British population is aged 65 and over, below the borough level of 14.1 per cent, but the second largest group after the White group

Black/African/Caribbean/Black British

- The Black/Black British group overall has a younger age profile than the borough average. However, there are marked differences between the individual groups which make up this category, with the Black Caribbean group having a much older profile than the Black African and Other Black groups.
- Only 4.9 per cent (337) of Black Caribbean residents are aged 0 to 4, whilst 13.1 per cent of the Other Black group are aged four and under
- At age 5 to 15 there are variations between the different Black/Black British groups. 13.2 per cent of Harrow's Black Caribbean community are of this age, compared to 22.3 per cent of Black Africans and 30.2 per cent of those who are Other Black.
- At working age the proportion of Black/Black British residents who are of this age (64.1%) is similar to the borough average of 65.8 per cent. However at age 65 and over only 6.2 per cent of Harrow's Black/Black British group are of this age, much lower than the borough average of 14.1 per cent. There are large variations within this group, from a high of 12.2 per cent for the Black Caribbean group to a low of 2.3 per cent for the Other Black group.

Other Ethnic Groups

- 7,050 (2.9%) of Harrow's residents come from Other ethnic groups, the smallest of the five broad ethnic group categories in Harrow
- Other ethnic groups have a younger age profile compared to the borough average, in particular the Arab group
- 12.4 per cent of the Arab group population are young children aged four and under, much higher than the borough average of 6.7 per cent
- Similarly the Arab group has higher percentages of children aged 5 to 15 (25.5%), but lower proportions of residents of working and retirement age

3. Ethnic Group by Religion (Table 3)

- Christianity is Harrow's most common religion with 37.3 per cent (89,181) of followers
- 71 per cent of Harrow's Christian population are of White ethnicity, comprised of the following groups: 67.6 per cent White British; 10.2 per cent White Irish; 0.2 per cent Gypsy/Irish Traveller; and 22 per cent White Other
- 14.1 per cent (12,538 people) of Harrow's Christian group is comprised of residents of Black/Black British origin, the second highest broad ethnic group
- Hindus form Harrow's second largest religious group and is the country's largest Hindu community with 60,407 residents. 97 per cent of Hindus are of Asian/Asian British origin.
- Harrow's Muslim community is one of the borough's most ethnically diverse groups, originating from a number of different backgrounds. Nearly two-thirds (61.4%) are of Asian/Asian British origin; 14.1 per cent are Black/Black British; 13.4 per cent are from Other Groups (mainly Arab); 7 per cent are from White groups; and 4.1 per cent are from Mixed/Multiple ethnic groups.
- 95 per cent of Harrow's Jewish community come from the White ethnic groups
- 86 per cent of Harrow's Sikh residents are Asian/Asian British, a similar level to the borough's Buddhist community, at 87 per cent
- Harrow is ranked first nationally for people with Other Religions, with 5,945 people. 99 per cent of people who follow other religions in Harrow are Asian/Asian British, which is borne out by the fact that Jainism is the most practised religion in Harrow of these Other Religions.
- 22,871 people in Harrow (9.6%) stated that they have no religion. 71 per cent of those with no religion are of White ethnicity; and nearly nine per cent are of Mixed race.
- The 2011 Census question on religion was a voluntary question and 14,781 residents (6.2%) didn't answer this question. Over half (53.4%) who chose not to answer this question were of White ethnicity and 29 per cent were Asian/Asian British.

4. Ethnic Group by Health and Limiting Long-Term Illness (Tables 4, 5 & 6)

General health is a self-assessment of a person's general state of health. People were asked to assess whether their health was very good, good, fair, bad or very bad. This assessment is not based on a person's health over any specified period of time. In this paper 'good health' combines the 2011 Census categories of very good health and good health, whilst 'not good health' is based on fair health, bad health and very bad health.

- 83.6 per cent (199,800) of Harrow's residents considered their health to be good in 2001, above the national average of 81.6 per cent
- Conversely 16.4 per cent (39,256) people do not consider their health to be good
- Overall 19 per cent (19,227) of residents in the White group do not have good health, the highest proportion reported of the broad ethnic group categories. The Gypsy/Irish Traveller group within the White category are in the poorest health with 27.1 per cent (49 out of 181 residents), followed by White Irish (22.6%) and White British (21%).

- The Mixed/multiple ethnic group category has the best levels of health overall with 91.8 per cent stating that their health is good/very good
- 1.1 per cent (2,638) of all residents consider their health to be very bad, with the Gypsy/Irish Traveller group reporting the highest level, at 2.2 per cent (just four people). Other ethnic groups with higher levels of very bad health are the Arab group (1.9%, 71) and Bangladeshis (1.7%, 23).

Bad or Very Bad Health

• Bad or very bad health affects older people more (Table 5). Of those with bad or very bad health 47.6 per cent of sufferers (5,202) are residents aged 65 and over. 54.7 per cent (2,926) of residents from the White group (with bad or very bad health) are aged 65 and over, whilst the lowest rate, at only 18.1 per cent, is for residents from the Mixed/multiple ethnic group.

- Overall, 49 per cent (5,350) of all residents in bad/very bad health are from the White groups; 2 per cent (226) are of Mixed race; 39 per cent (4,259) are Asian/Asian British; 6.3 per cent (685) are Black/Black British; and 3.7 per cent (407) are from Other ethnic groups.
- 3 per cent of children (330) aged 15 and under were reported to be in poor health in the 2011 Census. The Mixed race group had the highest level, at 13.3 per cent (30), followed by the Black/Black British group at 7.9 per cent (54).

Limiting Long-Term Illness (LLTI): Day-to-day activities limited a lot

A limiting long-term illness is a long-term health problem or disability that limits a person's day-to-day activities, and has lasted, or is expected to last at least 12 months. This includes problems that are related to old age. People were asked to assess whether their daily activities were limited a lot or a little by such a health problem, or whether their daily activities were not limited at all.

- 16,187 (6.8%) people in Harrow have a limiting long-term illness/health problem or disability that affects their day-to-day activities a lot.
- Limiting long-term illness (LLTI) generally affects older people to a greater extent and overall 54 per cent (8,724) of residents aged 65 and over have a LLTI that limits their activities a lot (Table 6). The next largest group greatly affected by LLTI is the working age group (age 16 to 64). 42 per cent (6,788) residents with a LLTI, that limits day-to-day activities a lot, are of working age. Just 4.1 per cent (655) of the 16,167 residents with a severely limiting LLTI are aged 15 and under.
- In the White group LLTI, which limits activities a lot, increases with age and 62.4 per cent
 of all White residents with a very limiting LLTI are aged 65 and over. In the Mixed race
 group the highest percentages of people with a very limiting LLTI are aged 16 to 49, at
 41.5 per cent. Similarly in the Black/Black British and Other ethnic groups there are more
 people aged 16 to 49 with a LLTI, at 38.2 per cent and 37.6 per cent respectively.
- Overall only 4.1 per cent (655) of people with a severely limiting LLTI are children aged 15 and under, but in the Mixed/multiple ethnic group category this proportion is much higher, at 23.3 per cent
