Strong management controls and effective training of all staff so that they are aware of premises license and the requirements to meet the four licensing objectives with the particular attention to no underage drinking or supply of alcohol to underage people both for on and off sales, drunk and disorderly behavior on the premises and when leaving, vigilance in preventing the use and sale of illegal drugs, violent and antisocial behavior and ensuring no harm to children.
