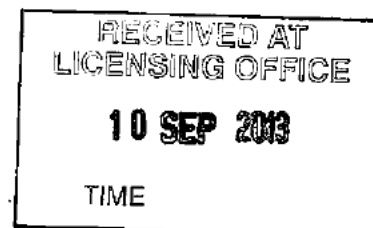

These premises previously had the benefit of a Premises Licence (LN/00000690) which unfortunately lapsed due to liquidation of the company that was the Premises Licence Holder. The proposed operation of premises will remain the same as before - a restaurant serving alcohol with table meals only. Adequate levels of staff will be employed and appropriately trained to meet the requirements for health and safety

b) The prevention of crime and disorder

Acceptable forms of identification (but not limited to) PASS approved proof of age cards, valid passport and photocard driving licence.

Staff are trained in under age sale prevention and this training will be regularly internally revalidated .

c) Public safety

Exit doors and fire safety equipment will be regularly checked to ensure satisfactory function. Current locations of fire safety equipment is demarcated on the attached plan.

In areas accessible by the public with inadequate daylight, suitable and sufficient lighting is currently provided and maintained.

All staff are fully trained in health and safety, and evacuation procedures. This training will be regularly internally revalidated.

d) The prevention of public nuisance

Where necessary, noise levels will be maintained by the Manager and Designated Premises Supervisor. All reasonable measures will be taken to ensure the limitation of noise. As detailed earlier, licensable activities will finish in good time before the premises closes to the public to allow orderly departure.

Guests will be encouraged to limit any noise when leaving or arriving at the premises late at night. Until April 2013 a restaurant (La Giralda) was operating on these premises with no public nuisance issues.


