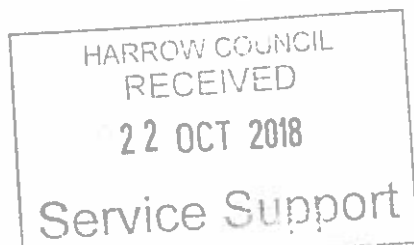

D/S will be present at premises during operational hours. The premises reserve the right to refuse service to customers displaying inappropriate behaviour and/or under influence of alcohol, disturbing other customers / members of public. We comply with mandatory availability of smaller measurements (which also has impact on discovery of drink driving)

b) The prevention of crime and disorder

CCTV system data captured on CCTV is fit for purpose and retained for period in line with local licencing conditions (31 days) and is available on request from police at all times during operational hours. There is also "incident book" where all incidents must be recorded (including date + time details)

c) Public safety

Our premises has adequate fire detection warning system in place. Fire exits are kept free from obstructions at all times. Fire equipment is inspected / serviced annually. We prevent patrons leaving premises with drink (plus bottles).

d) The prevention of public nuisance

Permanently displayed notice requesting all patrons to respect the needs of local residents and leave our premises / area quietly.

e) The protection of children from harm

The premises implement "Challenge 21" policy. Poster of challenge 21 is displayed at the premises, whereby all customers who appear to be under age must produce photographic identification in the form of passport / driving licence / proof of Age Scheme before buying alcohol.
