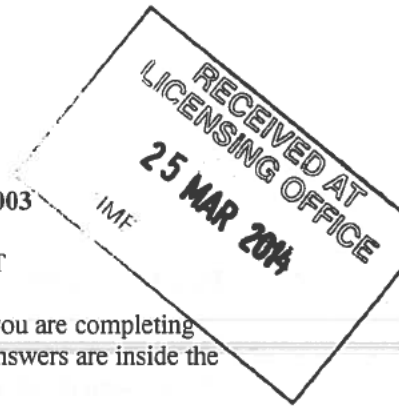

This application is to extend the sale of alcohol by 30 min to restore to the position. AS per the Guidance we are looking to provide a longer drinking up time there by a gradual and more manageable dispersal of patrons, which should promote the Licensing Objectives. In line with this, we are of the opinion the current conditions are adequate to facilitate this variation without any further conditions. It is our view that this extended dispersal period would negate some of the current conditions and we may in the future look to remove some of those conditions further to a brief period on the new hours.

b) The prevention of crime and disorder

The extended drinking up period should facilitate the promotion of licensing objectives without further restrictions.

c) Public safety

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates.
