- 4.—(1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that
- (a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i)beer or cider: 1/2 pint;
- (ii)gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii)still wine in a glass: 125 ml; and 250 ml
- (b)customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the operating Schedule

- 1: The premises shall operate a "challenge 21" policy for sale of alcohol.
- 2: The CCTV system to be maintained and operated in good order and to the satisfaction of the metropolitan police crime prevention officer's reasonable requests. The medium upon which the images are recorded will be clearly identifiable, stored securely, retained for a period of not less than 31 days and will be made available to council and police on request.
- 3: A monitored central alarm must be installed by either a NACOSS or SSIAB affiliated installer.
- 4: A safe controlled by a time delay method will be installed and will achieve the following. Restrict access for at least three minutes, to deter criminals from accessing the surplus or reserve value during any robbery. The safe will be either bolted to a solid wall and/or solid floor or buried in a solid wall and/or solid floor.
