M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

All staff engaged in the sale of alcoholic products will be trained in respect of their legal and social responsibilities whilst doing so. They will also be trained in respect of the contents of the premises licence, including any conditions contained therein.

A record will be maintained in respect of all staff training, and this shall be produced for inspection by the Police or Authorised Officers of the Licensing Authority upon request.

The premises shall primarily (but not exclusively) be selling alcohol products when accompanied by another item, for example, gift packed with chocolates or as part of a hamper. Sales will be made either in the premises or via the internet.

The alcohol products sold from the premises shall be fine wines and champagne only.

b) The prevention of crime and disorder

CCTV shall be installed at the premises and recorded images will be retained for 31 days. Recorded images shall be provided to the police or authorised officers upon reasonable request.

The premises will have roller shutters at the front as a security measure.

No more than 10% of the total display area in the shop shall be for alcohol products.

c) Public safety

Staff will be trained in respect of the fire risk assessment, and the health and safety risk assessment. A record of this training shall be produced for inspection by the police or authorised officers of the licensing authority upon request.

Relevant notices in respect of health and safety issues will be displayed as required.

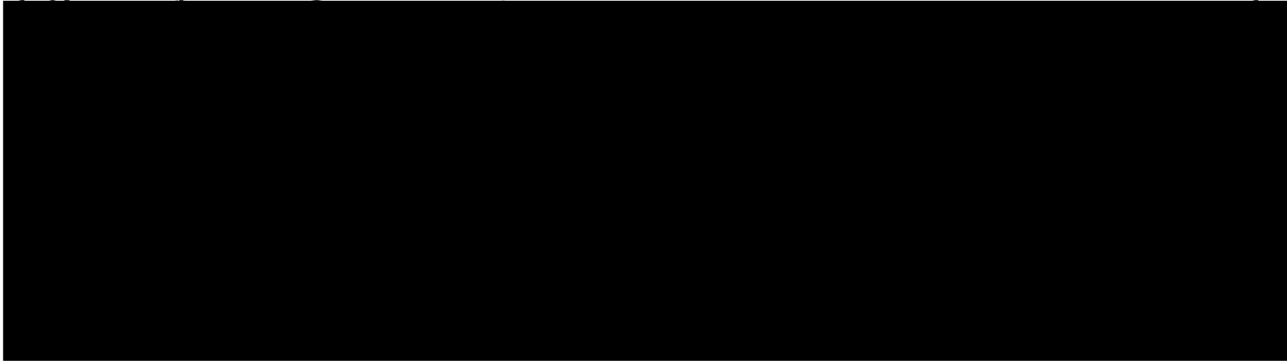

The premises shall adopt 'challenge 25' as its age verification policy, and staff shall be trained in respect of this policy.

A notice will be displayed at the premises advising customers that 'Challenge 25' is in operation at the premises.

A log shall be maintained at the premises which shall record any instances where ID has been requested and a sale of an alcoholic product refused. The log will be produced to the police or authorised officer of the licensing authority upon request.

Age verification will be required on the internet facility from customers ordering alcoholic products, and payment for internet transactions shall be by credit card only.



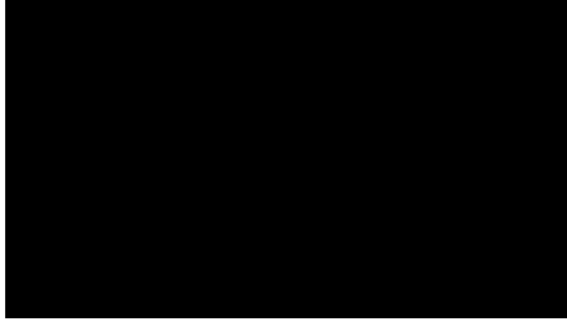
