The premises licence applicant has considered the operation of the building and mindful of 4 licensing objectives.

All staff will be trained and training records maintained on the site and available for inspection at any time.

Staff should be trained for give first aid

A First aid kit should store in the premises

Refresher courses should be carried out at 6 months intervals.

b) The prevention of crime and disorder

A member of management supervisor team will be in the premises at all time when the hall is open.

Premise has CCTV cameras that cover all of the shop inside, outside all the exit doors including voice recording. Images will be retained for a minimum 30 days and made available subject to compliance with data protection legislation to the police for inspection on request.

CCTV system is regularly served by qualified maintenance technician.

All incidents of crime and disorder will be logged and reported to the police as soon as possible.

Employ a door supervisor.

c) Public safety

All staff is required to attend comprehensive safety training to ensure that safe working method are adopted and all staff are trained in the evacuation procedure in the event of a fire or other dangerous occurrence. The shop sign displays a policy confirming the rules and regulation when supplying alcohol. Prepare a policy statement which includes four licensing objectives and supply a copy of the same to the customer who book the venue.

Every person who books the venue has to go through the rules and regulations and understand our policy. Female supervisor should be employed to supervise lady customers.

Use paper glasses and tuff glass.

d) The prevention of public nuisance

Refuse will be disposed of in an appropriate manner at all times.

Appropriate signage will be displayed asking customers to leave the premises in a respectful and quiet manner at all times.

All the doors keep closed

Installation of acoustic curtains or rubber speaker mount

e) The protection of children from harm

No sale of alcohol at any time persons under 18 (staff should ask to check the identity)

Children less than 18 years old should accompanied an adult in establishment.

The importance of not selling Alcohol to persons under the age of 18 should be emphasised in the training.
