

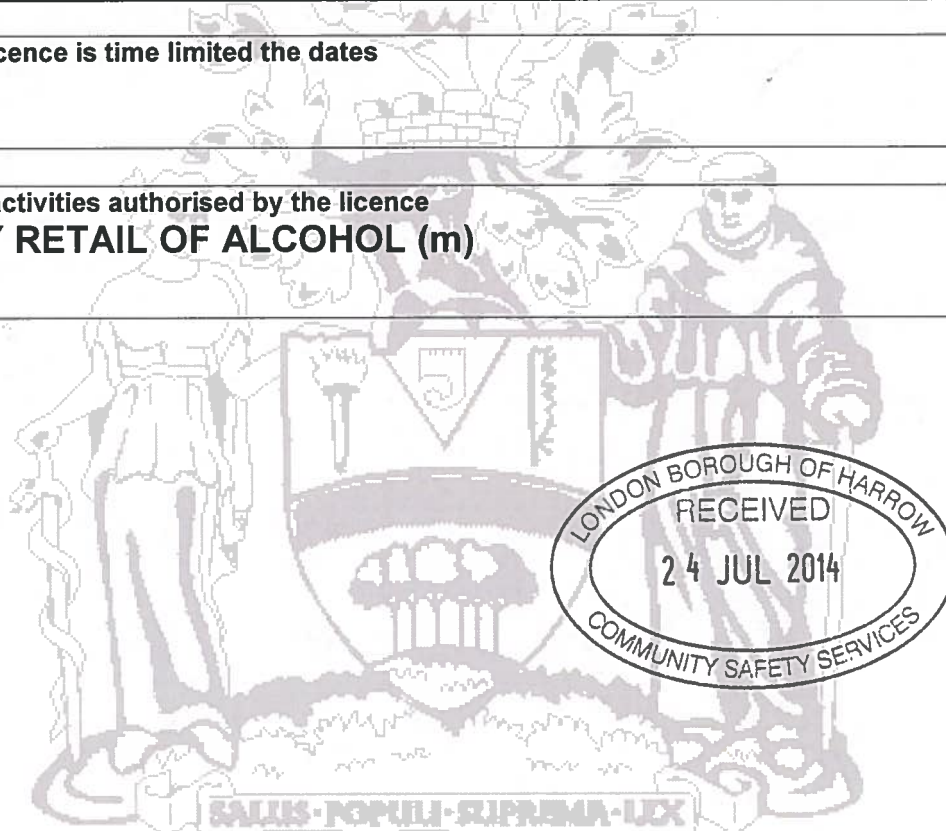

- 1) CCTV has been installed and will be operated and maintained in accordance with the reasonable specifications of the Metropolitan Police Crime Prevention Officer: images are to be securely stored and kept for a minimum of 14 days and made available to officers of the police or local authority upon request.**
- 2) A monitored central station alarm and security system to be maintained and operated in accordance with the reasonable specification of the Metropolitan Police Crime Prevention Officer**
- 3) Three members of staff will be on duty on the premises at all times after 2300**
- 4) A 'Challenge 21' policy shall be operated, whereby customers wishing to purchase alcohol or other age restricted products, and who appear to be under 21 years of age, will be asked to provide proof (such as a passport, driver's licence or other such accredited form of identification) to show that they are over 18 years of age.**

1.SUPPLY OF ALCOHOL

- (1) NO SUPPLY OF ALCOHOL MAY BE MADE UNDER THE PREMISES LICENCE –**
- (a) AT A TIME WHEN THERE IS NO DESIGNATED PREMISES SUPERVISOR IN RESPECT OF THE PREMISES LICENCE, OR**
 - (b) AT A TIME WHEN THE DESIGNATED PREMISES SUPERVISOR DOES NOT HOLD A PERSONAL LICENCE OR HIS PERSONAL LICENCE IS SUSPENDED**

2.DOOR SUPERVISION

- (1) WHERE A PREMISES LICENCE INCLUDES A CONDITION THAT AT SPECIFIED TIMES ONE OR MORE INDIVIDUALS MUST BE AT THE PREMISES TO CARRY OUT A SECURITY ACTIVITY, THE LICENCE MUST INCLUDE A CONDITION THAT EACH SUCH INDIVIDUAL MUST BE LICENSED BY THE SECURITY INDUSTRY AUTHORITY**
- (2) BUT NOTHING IN SUBSECTION (1) REQUIRES SUCH A CONDITION TO BE IMPOSED-**
- (A) IN RESPECT OF PREMISES WITHIN PARAGRAPH 8(3)(A) OF SCHEDULE 2 TO THE PRIVATE SECURITY INDUSTRY ACT 2001 (C.12) (PREMISES WITH PREMISES LICENCES AUTHORISING PLAYS OR FILMS), OR**
 - (B) IN RESPECT OF PREMISES IN RELATION TO-**
 - (i) ANY OCCASION MENTIONED IN PARAGRAPH 8(3)(B) OR (C) OF THAT SCHEDULE (PREMISES BEING USED EXCLUSIVELY BY CLUB WITH CLUB PREMISES CERTIFICATE, UNDER A TEMPORARY EVENT NOTICE AUTHORISING PLAYS OR FILMS OR UNDER A GAMING LICENCE), OR**
 - (ii) ANY OCCASION WITHIN PARAGRAPH 8(3)(D) OF THAT SCHEDULE (OCCASIONS PRESCRIBED BY REGULATIONS UNDER THAT ACT).**
- (3) FOR THE PURPOSES OF THIS SECTION-**
- (A) "SECURITY ACTIVITY" MEANS AN ACTIVITY TO WHICH PARAGRAPH 2(1)(A) OF THAT SCHEDULE APPLIES, AND**
 - (B) PARAGRAPH 8(5) OF THAT SCHEDULE (INTERPRETATION OF REFERENCES TO AN OCCASION) APPLIES AS IT APPLIES IN RELATION TO PARAGRAPH 8 OF THAT SCHEDULE**

(3) EXHIBITION OF FILMS

- 1) WHERE A PREMISES LICENCE AUTHORISES THE EXHIBITION OF FILMS, THE LICENCE MUST INCLUDE A CONDITION REQUIRING THE ADMISSION OF CHILDREN TO THE EXHIBITION OF ANY FILM TO BE RESTRICTED IN ACCORDANCE WITH THIS SECTION.**
- 2) WHERE THE FILM CLASSIFICATION BODY IS SPECIFIED IN THE LICENCE, UNLESS SUBSECTION (3)(B) APPLIES, ADMISSION OF CHILDREN MUST BE RESTRICTED IN ACCORDANCE WITH ANY RECOMMENDATION MADE BY THAT BODY.**
- 3) WHERE-**
- (A) THE FILM CLASSIFICATION BODY IS NOT SPECIFIED IN THE LICENCE, OR**
 - (B) THE RELEVANT LICENSING AUTHORITY HAS NOTIFIED THE HOLDER OF THE LICENCE THAT THIS SUBSECTION APPLIES TO THE FILM IN QUESTION,**
- ADMISSION OF CHILDREN MUST BE RESTRICTED IN ACCORDANCE WITH ANY RECOMMENDATION MADE BY THAT LICENSING AUTHORITY.**
- 4) IN THIS SECTION-**
- "CHILDREN" MEANS PERSONS AGED UNDER 18; AND**
 - "FILM CLASSIFICATION BODY" MEANS THE PERSON OR PERSONS DESIGNATED AS THE AUTHORITY UNDER SECTION 4 OF THE VIDEO RECORDINGS ACT 1984 (C.39) (AUTHORITY TO DETERMINE SUITABILITY OF VIDEO WORKS FOR CLASSIFICATION).**

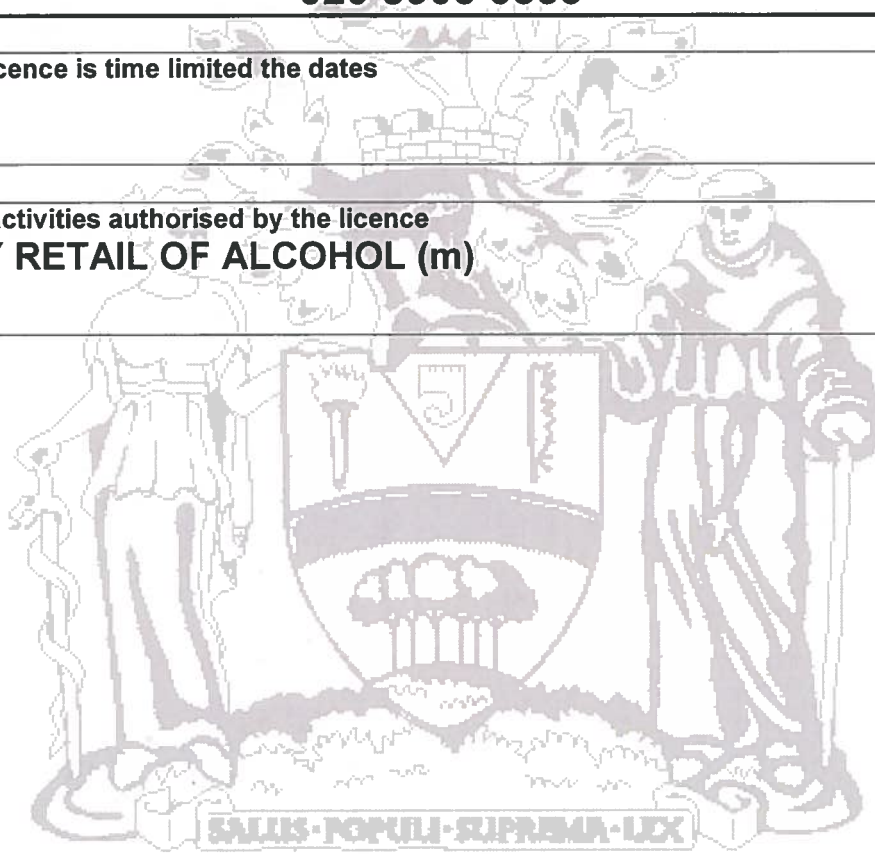

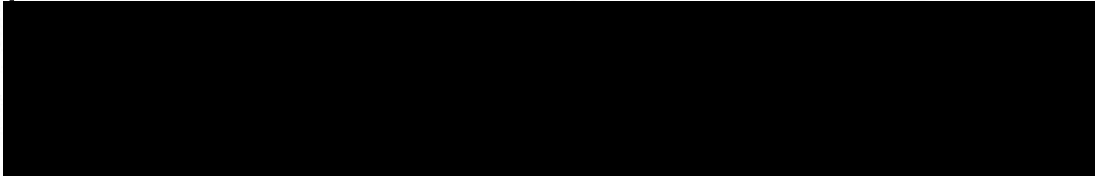
