VARIATION TO THEIR PREMISES LICENCE  
THE PROPOSAL IN THIS APPLICATION IS:**

The application for variation is to :

- Amend layout to that shown on the plan accompanying this application (drawing no 112/53-205B Ground Floor and 112/53-255B for first floor and basement facilities). The ground floor customer trading layout is now dedicated to seating for diners, and the bar is removed.
- Remove conditions 5 and 6 of Annex 2 and substitute with the two conditions offered below to ensure the promotion of the Protection of Children from Harm licensing objective.

The substituted conditions offered are :

- Each member of staff authorised to sell alcohol will receive adequate training on the law with regard to alcohol sales. All training will be properly documented and retained. The training records will be kept on the premises and made available for inspection by authorised officers.
- The licence holder will operate a Challenge 21 policy at the premises. Signage shall be displayed inside the restaurant informing customers of this policy.
