Removal of conditions 4, 5, and 6 under Annex 2:

6. All children must be accompanied by an adult

Removal of condition 1 under Annex 3:

1. The maximum occupancy of the building at any time shall not exceed 50 persons until such time as an alternative means of fire escape is provided to satisfaction of the fire authority. (covered under separate legislation)

To add the following conditions to the licence under Annex 2:

4. All children must be accompanied by adult when on the premises
5. Children are permitted on the premises until 21:00 hours, unless taking part in the table meal or function when they will be permitted to remain on the premises until the end of that meal or function
