Annex 2: Amend conditions

1. Licensees will attend regular meetings with local police upon their request.
3. No service to under 18s in the bar (excluding soft drinks).
5. When Door supervisors are required to be present at the police's request, a least one female door supervisor shall be employed and available where appropriate.
6. Whilst licensable activities are taking place, there should be a minimum of one security officer on duty on the premises until the premises is closed.

Remove conditions on Annex 2:

7. The police have an absolute veto to reinstate the previous conditions (as per Issue 8 of the licence) following any problems at the premises.
