What are local statistics telling us?

At its March 2017 meeting the HSAB looked in depth at the domestic abuse (DVA) statistics for vulnerable adults – as a follow up to the February conference. The headlines were that:

- 101 cases dealt with by Safeguarding Adults Teams had an element of DVA
- the ethnicity proportions were 44% BME to 56% white - bearing out the research that DVA exists across all communities
- the female / male split was 71% / 29% with no significant variations by ethnic group
- older people were the most at risk group and also women with mental health issues
- the most prevalent form of abuse is emotional and psychological
- most referrals are coming from health staff (47%) followed by social care staff (22%) and the Police (11%)
