**Human trafficking** involves the use of force, deception or coercion to exploit someone to obtain some type of labour, crime or sex act from them. It is a hidden crime encompassing adult and child victims who rarely come forward to seek help because of language barriers, threats, fear of the traffickers, and/or fear of being criminalized.

Traffickers use force, deception, or coercion to lure their victims and force them into labour, criminality or sexual exploitation. They look for people who are susceptible for a variety of reasons, including psychological or emotional vulnerability or economic hardship. The trauma caused by the traffickers can be so great that many may not identify themselves as victims or ask for help. There are several broad categories of exploitation linked to human trafficking, these can include:

- sexual exploitation
- forced labour and domestic servitude
- organ harvesting
- child related crimes such as child sexual exploitation CSE
- criminal exploitation forced begging, illegal drug cultivation, organised theft, related benefit frauds etc
- forced marriage

## **Coercion and Control**

"I don't want to badmouth my children you see......
So really it is my problem"

Coercion, control or undue influence may prevent an adult from making use of their mental capacity to make their own decisions. In safeguarding work where adults with capacity determine what action they want taken in enquiries it is therefore particularly important to be aware of any undue influence being put on them.

Coercive control is now recognised as the behaviour that underpins domestic abuse. It is a pattern of behaviour which seeks to take away the victim's sense of self, minimising their freedom of action and violating their human rights. The Serious Crime Act 2015 created a new offence of controlling or coercive behaviour in intimate or familial relationships. The new offence closes a gap in the law around this type of behaviour (in an ongoing relationship between intimate partners or family members) which: (i) takes place "repeatedly or continuously"; (ii) where the victim and alleged perpetrator are "personally connected" at the time; and (iii) which has a "serious effect" on the victim.



If an adult at risk retains mental capacity to make decisions but is unable to fully exercise this capacity due to evidenced coercion and control, an order can be sought from the High Court as a 'safety net' to allow them a period of decision-making without undue influence.
