The Harrow (Speed Limit) (Amendment No. 52) Traffic Order 2020
The Harrow (Waiting and Loading Restriction) (Amendment No. 95) Traffic Order
2020



1. NOTICE IS HEREBY GIVEN that the London Borough of Harrow has made the above mentioned orders under Section 6, 7, 83, 84, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and all other enabling powers. The general effect of the orders would be as follows;
2. The Harrow (Speed Limit) (Amendment No. 52) Traffic Order 2020 creates a 20mph zone in the Kingshill Avenue area including the following roads; Addiscombe Close, Alicia Avenue, Alicia Close, Alicia Gardens, Becmead Avenue, Boxmoor Road, Bradenham Road, Brampton Grove, Elmsleigh Avenue, Hillbury Avenue, Hughenden Avenue, Kentonian Close, Kingshill Avenue, Mayfield Avenue, Penn Close, Prestwood Avenue, Prestwood Close St. Leonard's Avenue, St. Mary's View, Willowcourt Avenue and Wykeham Road.
3. The Harrow (Waiting & loading restriction) (Amendment No. 95) Traffic Order 2020 extends the existing at any time waiting restrictions in Alicia Avenue to protect a new traffic island.
4. A copy of the orders, which will come into operation on 2nd March 2020, including documents giving more particulars of the orders, are available for inspection at request between 9am and 5pm, Mondays to Fridays at the One Stop Shop at the Civic Centre, until 6 weeks from the date on which the order was made.
5. If any person wishes to question the validity of the orders or their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within six weeks of the date on which the order is made, apply for the purpose to the High Court.
