To reduce the burden on premises that have had to close Harrow Council Licensing has decided to waive the licence fees for the period of closure due to the Health Protection (Coronavirus, Restrictions) (England) Regulations 2020 where possible.

When you are ready to reopen please refer to the Special Treatment Licence Fee structure provided below and email licensing@harrow.gov.uk to request a fee reduction for the period of closure. You will be sent a figure which will need to then be paid via the online payment option.

NB: The quoted application amount and enforcement fee of £92 per band **will not** be subject to any further reduction unless agreed otherwise with Commercial Licensing
