Regeneration Update

Preparing the ground | Focusing on demolition Minimising disruption | Looking out for wildlife

Work onsite is progressing well. Higgins are continuing to undertake **ground tests**, building up a full picture of the soil condition – this will enable them to prepare the ground for construction. They've also started the **demolition survey**, investigating the best method to demolish the existing buildings to **minimise dust**, **noise and waste**. They're also checking for any nesting bats or birds that could be disturbed by the work.

This month Higgins will start disconnecting gas, water and electricity from the buildings to be demolished. This may cause some temporary disruption to footpaths and roads. Access will be maintained and there'll be **minimal impact on residents**. See the noticeboard at the site entrance for further details of the upcoming works. If you have any concerns, please visit John Howard in the site compound or contact him via the details on the back page.

We're considering an event in February/March to formally mark the start of Phase 1. We'll involve residents in its planning and will circulate more details when available. We're also now looking at the procurement process for Phases 2 and 3, which will deliver the remaining 485 homes planned for the estate. It will be important to select the right development partner to work with us and residents. This process will start in spring with the intention of selecting a partner by April 2021.
