Steering Group AGM and elections

The Grange Farm Steering Group are holding their Annual General Meeting and elections on Thursday 30 April 2020 at the Grange Farm Community Centre, 65 Osmond Close, at 7pm.

This is when one third of the Steering Group members stand down, and nominations from other residents are accepted. Members can re-stand should they wish, and potential new members must attend two meetings before the April AGM meeting and live on the estate.

Level of involvement

Steering Group members meet twice a month on the estate and get involved in leaflet drops, fun days, community days, site visits and estate walkabouts among other things.
