Back on site



- 20 April Higgins re-opened their site and have gradually ramped up activity
- Higgins are abiding by strict social distancing guidelines
- From the end of May, there were 14 operatives on site working on a range of activities, including asbestos removal and other material generated from the 'soft strip' inside the blocks
- In readiness for removing further material, Higgins have issued the relevant 2-week notice to the Health & Safety Executive (HSE)
- 3 June work started on temporary propping of internal walls to allow for final pre-demolition works
- 13 July current planned demolition start date.

Higgins construction update

As many of you may have been aware, during the lockdown I have remained on site (self-isolating). This has given me an ideal opportunity to plan and programme upcoming works which have been affected by the current situation.

The good news is that we are all back at work and have resumed normal production, which at the current stage means carrying out the soft strip of all the blocks and isolating the services such as gas, electric and water which has to be done prior to the hard demolition.

We will carry out the first stage of the hard demolition to block 1, 10–18 Osmond Close in late June/early July and then block 2, 1–9 Osmond Close. This will enable us to move the present compound to its new position and start works to the new road.

Hoardings - We're progressing with the illustrated boards to go on the hoardings along Shaftesbury Avenue later this month. We have liaised closely with both the Resident Steering Group and MyYard.

CCTV update - Once the main construction works start, the site operational requirements mean that the Council needs to relocate the CCTV mast adjacent to the Higgins site. This will be done over the next few weeks.



New fob system on communal doors

We're installing a new fob system on communal doors to improve security and reduce the risk of anti-social behaviour.

Work has already started to install the system, which features a magnetic lock, onto the existing doors.

Residents will be given three fobs per household. 16 blocks will be fitted with the new locks initially and then the remaining ones, with all the work due to finish in early September. We anticipate the new system will reduce antisocial behaviour and increase security to the blocks.

Ordering a replacement fob will incur a cost. Residents should follow the same procedure as with any other repair, by reporting it on the online housing portal (www.harrow.gov.uk/ housingportal) or calling 0208 910 2630.

Meetings on the estate - continuing disruption

We can't hold the Thursday drop-ins at the Community Centre at the moment due to Covid restrictions. This could change soon and we will let you know if it does. If you have any queries, please contact the relevant department - details are on the back page.

We hope to have some news about when estate walkabouts will restart for the next newsletter. Grange Farm Steering Group meetings will continue to be held once a month via Zoom. If you have any issues you wish to raise, please let Raj Kumar know - see back page for details.

The council continues to have monthly 'virtual' project meetings with Higgins to monitor the contract and ensure any delays are minimised.

Fun day plans on hold

Unfortunately we have had to cancel this year's Community Fun Day, which was planned for 25 July. This is due to the government's Covid 19 restrictions on the number of people allowed to congregate.

The Steering Group is considering other ways to support the residents on the estate. They've agreed with the council to provide enhanced internet access near the community centre via a booster system, so more people will be able to access free internet. Other ideas include an online raffle and a drawing competition. We've identified **22 August** as the day to pull this together.
