# Free Early Years childcare for two year olds (2YO)

Did you know that your 2 year old could qualify for up to 15 hours a week of free childcare for 38 weeks a year (570 hours over a year)?

### What is the offer?

Children become eligible from the school term after they turn 2 years old. They can get a maximum of 570 hours over a year or 15 hours per week over 38 weeks in a year.

Your chosen provider must have been inspected by Ofsted and be judged to be Good or Outstanding.

# Why should I consider using childcare – I can look after my own child?

Childcare can be good for your child. Research has shown that good quality early years education can:

- Improve your child's development, for example; their communication skills
- Help them learn to socialise with other children and make friends
- Help them begin to get ready for school
- Give them access to exciting places to play and new activities

### Childcare is also good for families - it can give you a bit more time to:

- Spend with your other children
- Take up a college course
- Go back to work or
- Pick up more ideas of what to do with your child at home and how you can help them develop and learn

# Could my child go to the nursery/pre-school/childminder near me that I've heard is good ?

All parents/carers of eligible children are able to access up to 15 hours a week of free early



years childcare and education, with an approved local nursery/pre-school or childminder, dependent on there being an available space for your child. You may have to pay for extra costs like meals, nappies or trips. ## What are the eligibility criteria for families?

Children **must** meet either criterion A, B, C or D to be eligible for funding.

**Criterion A:–** Economic: Children whose parents/carers are in receipt of one or more of the following benefits:

- Income Support
- Income based Job Seekers' Allowance (JSA)
- Income-related Employment and Support Allowance (ESA)
- Universal Credit if the combined household (both parents) income from work is £15,400 or less a year, after tax, not including benefit payments
- Tax Credits, and the combined household (both parents) income is £16,190 or less a year, before tax.
- Guaranteed Element of the State Pension Credit
- Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)

Criterion B:- Children looked after by the Local Authority:

- Child in Care 'looked after'
- Child has left care under an adoption order, special guardianship order or a child arangements order.

N.B. Details of a Social Worker able to verify the above information is required.

**Criterion C:** Child with Special Educational Needs and/or Disability as defined by:

- Children in receipt of Disability Living Allowance (DLA).
- Child with a current Statement of Special Educational Needs (SEND).
- Child with an Education, Health and Care (EHC) Plan.

Note: Documentation copies are required to verify eligibility for Criterion C.

**Criterion D:** Non-EEA citizen who cannot claim benefits and are getting support under the Immigration and Asylum Act:

- Claimed asylum in the UK and are waiting for a decision (known as 'part 6')
- Been refused asylum in the UK (known as 'section 4')
- If the combined household (both parents) income is £15,400 or less a year, after tax, and have either;
  - leave to remain with 'no recourse to public funds' on family or private life grounds
  - support from your local council because you have 'a child in need', for example they have a disability or a child protection plan
  - the right to live in the UK because the parent(s) are the main carer(s) of a British citizen (known as a 'Zambrano Carer')

Once a child has been agreed for the 2 year old funding they will continue to be funded even if the family's circumstances change at a later date.
