SH opened the meeting.

1 Apologies and Order of the Agenda

Apologies were received and accepted from: Nick Waldron – Headteacher, Pinner Park Primary School

The order of the agenda was agreed.

2 The minutes of the meeting held on 19 January 2021 were agreed.

3 Matters Arising

Growth Funding – general

In response to a number of schools expressing concern that NOR had increased significantly since the October 2020 census it was agreed that there would be a fund to support schools whose NOR has increased between October 2020 and May 2021 census. A diminimus will be applied so that schools will only be funded per pupil over a certain percentage increase which will be agreed after reviewing the overall census NOR changes. This will be brought back to a later schools forum.

4 DSG Budget Setting 2021-22

JF introduced the report which set out the latest 2021-22 settlement and the 2021-22 final school budgets approved by the DfE on 16 February 2021

Schools Block

JF explained that the proposed budgets brought to Schools Forum in January had remained unchanged.

High Needs Block

JF set out the movements in HNB funding for 2021-22. Despite a net funding increase there is still an expected in year deficit of approx. £1.4m which would result in a cumulative deficit of over £6m by March 2022.

JF set out the principles and questions in the DfE's HN National Funding Formula consultation and potential implications for Harrow.

5 DSG Budget Monitoring Q3 2020-21

JF set out the budget monitoring position for 2020-21. There is a projected overspend on the HNB of ± 1.755 m and a projected underspend on the growth fund of ± 155 k.

Early Years

JF explained that is likely to be a significant underspend on the EYB this financial year due to reduced participation due to Covid. In particular take up in the Spring Term has been low and there were approx. 500 pupils fewer on the January census than in the previous year. JF explained that not only will this impact on future funding but will likely lead to a claw back of funding. it could also mean that as more children start to attend nursery after lockdown the LA will be required to fund children who were not on the census. JF explained that any underspend would need to be earmarked for either clawback or funding additional children in 2021-22.

High Needs Block

JF explained that there is anticipated in year overspend on the HNB of £1.755m. This has reduced significantly since reported at Q2 due to all of the FE contracts now being finalised.

SH suggested that there had been a reduction in participation in FE due to COVID. This would explain why this years spend is approx. £400k lower than in the previous financial year.
