Estate regeneration - next steps

As you'll have seen, we're making good progress with the estate's regeneration. After so many years of planning, it's great to see these future homes taking shape.

With phase 1 well underway, our thoughts now turn to phases 2 and 3. That includes helping some people to move from Grange Farm, so that more properties can be demolished.

This newsletter shows how everyone living on the estate will be affected by the next stage of the work. This can depend on which phase your property's in and whether you are a secure tenant, a leaseholder/freeholder or if you were offered a home on Grange Farm as temporary accommodation.

For each of these groups, there's further information and sources of support inside.

BUILDING A BETTER HARROW



If you're in temporary accommodation

You may have to soon leave your property on the estate

- If you are in a phase 2 property, you will have to leave Grange Farm next year
- We'll support you to find somewhere else to live that meets your family's needs
- Speak to Pauline Dawes (details below) to understand next steps and your options
- We know that moving house is stressful, but we're here to support you
- You will shortly receive a formal Notice to Quit - we're required by law to issue this

- If you refuse the new home offered, the council may no longer have a responsibility to house you
- Check what moving means for your benefits by speaking to Citizens Advice Harrow on 0808 250 5705 / 020 8427 9477 or search 'benefits' on harrow.gov.uk
- If you are in a phase 3 property, you will not have to move from Grange Farm next year.

If you're a secure council tenant on the estate

You can move to your new home as soon as it's available

- If you live in a phase 2 property, you will be offered a new home when phase 1 is completed, due September 2022
- If you live in phase 3, you will stay in your home until new phase 2 homes are ready.
 We do not yet have a timescale for this.

Secure tenants in phase 2 properties will soon receive a Notice Of Seeking Possession. This is a legal formality - you will not have to move until your new home is ready.

If you're a tenant of Notting Hill Genesis

The council becomes your landlord. You'll move when phase 2 is built

- You will become a secure tenant of the council
- You will be entitled to a new home on the regenerated estate when phase
 2 is completed. We do not yet have a timescale for this
- We will make sure your new home meets your family's needs
- The council and Notting Hill Genesis will write to you with further information when the timing of your transfer to us is clearer.

If you're a leaseholder or freeholder

We need to buy your home so that the regeneration can go ahead

- The council is currently negotiating with you to buy your property
- As a fall back, we secured a Compulsory Purchase Order (CPO) in July
- A CPO means that you cannot refuse to sell your property to the council
- Independent adjudication is available if a price cannot be agreed
- CPO is a last resort we would prefer to agree a sale through our Buy Back scheme
