- Give yourself plenty of time to plan a procurement project to maximise the chances of delivering desired outcomes.
- Understand all your third party spend and ask yourself how you can make your funds go further.
- From the 01st January 2022, the following procurement thresholds apply to contracts awarded under the Public Contract Regulations 2015.

Works Contracts £5,336,937

Supply and Services £213,477

Services concerning social and other specific services (Also referred to as the light touch regime) £663,540

The new thresholds are inclusive of VAT due to the UK's obligations under the WTO. This means that more procurements will be caught from 1 January 2022 and require Find a Tender Service advertising.
