Copies of these objections will initially be sent to the applicant for their consideration.

Persons objecting to the grant of licences must be prepared to attend in person at a public hearing before the licensing committee of the council.

It is an offence to knowingly or recklessly make a false statement in connection with an application. A person found guilty of such an offence is liable upon summary conviction to a fine not exceeding £5,000.00
