WHEREAS the LONDON BOROUGH OF HARROW ("the Council") being the appropriate local planning authority within the meaning of Article 4(5) of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended) ("the Order"), is satisfied that it is expedient that development of the description set out in the First Schedule below should not be carried out on the land described in the Second Schedule below and shown shaded in red and black marks (for identification purposes only) on the map annexed hereto unless planning permission is granted for it on an application made under Part III of the Town and Country Planning Act 1990 (as amended).

NOW THEREFORE the Council in pursuance of the power conferred on it by Article 4(1) of the Order **HEREBY DIRECTS** that the permission granted by Article 3 of the said Order shall not apply to the development specified in the First Schedule below in respect of the land described in the Second Schedule below and shown shaded in red and black marks on the map annexed hereto.

FIRST SCHEDULE

DEVELOPMENT RIGHTS WITHDRAWN AS SET OUT BELOW FOR 116, 156, 158, 193 STANMORE HILL, By the Pond, Woodleigh, The Lodge, Wood Farm Cottage, Moor House, 1 & 2 Garage Cottages IN WOOD LANE, 3 AYLMER CLOSE AND 1, 2, 3, 12, 18, 19, 20, 21, 22 IN LITTLE COMMON WITHIN THE LITTLE COMMON CONSERVATION AREA SHOWN SHADED IN RED AND BLACK MARKS (FOR IDENTIFICATION PURPOSES ONLY) ON THE MAP ANNEXED HERETO

The following permitted development rights are withdrawn relating to Schedule 2 of the Town and Country Planning (General Permitted Development) Order 2015, where such development would front a highway, waterway or open space:


