The London Borough of Harrow

Knowing your neighbourhood

Harrow is one of 32 boroughs in London and is located in the North-West of the city.

Harrow has an estimated population of 251,200 residents. It prides itself in being one of the most ethnically and religiously diverse boroughs in the country with people of many different backgrounds living side by side. 69.1% of residents classify themselves as belonging to a minority ethnic group. It is the richness of this diversity and our vibrant community that makes Harrow a great place to live and work.





Harrow Council services

Harrow Council is the local authority that is responsible for all the public services and facilities in the borough. The council is responsible for functions such as schools, housing, social care, registrar services, waste collection, planning, and other administrative services.

To learn about the work of the council and things happening in your area, follow their social media feeds – search for 'Harrow Council' on Facebook or Twitter. The council's magazine, Harrow People, will be delivered to your home and can also be read in local libraries.

Harrow has 6 public libraries that can be used for free by residents and are usually open 7 days a week. There are more than 60 areas of parkland and open spaces covering more than 400 hectares. These include recreation grounds, parks and other green spaces which cover one-fifth of the area of the borough. As well as meadows, playground, extensive woodlands and ponds, the areas host rich wildlife and plant life.

Residents and community groups can host events in the parks or open spaces. Information about where these are situated, the facilities available, how to get permission to organise an event, or how to report an environment or parks issue can be found on Harrow Council's website.

Harrow residents also have access to leisure centres offering a wide range of facilities for sports and wellbeing. Harrow Leisure Centre is the principal swimming and indoor sport facility within the Borough.

Transport

Harrow is well-connected to the rest of London including four London Underground Lines, the London Overground, and mainline rail services. The borough's largest and busiest station is Harrow on the Hill station in Harrow Town Centre. Although trains tend to be quicker, the cheapest mode of public transport is by bus. There are 37 bus routes including 5-night bus services serving areas within the borough and neighbouring boroughs.

The best way to travel on public transport is by purchasing a pre-paid card known as an Oyster Card, which can be used on all services. Children benefit from free and discounted travel. Children under the age of 5 travel free of charge, all other children can pay discounted fares, depending on their age. Information is available online at:

If you are driving in Harrow and need parking, please check carefully if street parking is allowed, the time brackets available for free parking, or if you need to apply for a parking permit for where you live. Applications can be made online on Harrow Council's website.

Health and wellbeing

Doctor services

The National Health Service (NHS) provides health services to people living in the UK. Most of these services are free. In the UK, family doctors are called General Practitioners "GPs". A GP is the first doctor you will see when accessing healthcare. To receive medical treatment, you and your children must register with a GP as soon as possible.

To find GPs in Harrow near where you live, you can use the NHS website via this link: www.nhs.uk/Service-Search/GP/LocationSearch/4 Once you locate a GP that accepts new patients, you can contact their practice to start the registration process which could be done online or in person, depending on the practice procedures.

Urgent care

If you have an urgent medical problem and you're not sure what to do – call 111. This NHS service will provide you with advice. You can also speak to a pharmacist.

For emergency health care, you can attend one of the Accident & Emergency (A&E) services in Harrow. Find out more about these at harrowccg.nhs.uk

Call 999 in a medical or mental health emergency. This is when someone is seriously ill or injured and their life is at risk.

Interpreters can be provided by most health services providers. You can speak to your GP practice and request one if you have an appointment or request interpreting on the phone when you call 111 or 999.

Covid

Covid vaccinations are available for free to Harrow residents. Booking a vaccine depends on whether you are registered with a GP or not. Walk-in vaccination centres are also available. Childcare and education

School

Most children who move to the UK from overseas have the right to attend a school in England. Harrow Council is the admissions authority for all Harrow community schools. The Council does not manage private schools and academies.

In the UK, education is compulsory for all children aged over 5 and under 16. For children needing to apply for a school place for primary (5 to 10) or secondary education (11 to 16) in Harrow, please visit the Council's webpage at: www.harrow.gov.uk/schools-learning. An application should be made as soon as the child arrives in the UK.

Younger children


All 3 and 4-year-olds in England are entitled to 570 hours of free early education or childcare a year. This is often taken as 15 hours each week for 38 weeks of the year. Some 2-year-olds are also eligible.

Day nurseries, pre-schools and playgroups are registered by Ofsted (The Office for Standards in Education, Children's Services and Skills) to provide care and early education for children from birth to age five. After leaving school

There are several educational options for those aged 16 and finishing their secondary education. They can:

- stay in full-time education for example at school, sixth form college, further education college or University Technical College (UTC)
- start an apprenticeship or traineeship
- spend 20 hours or more a week working or volunteering while also doing parttime education or training

Employment, skills and volunteering

Help to find work or training

Ukrainian nationals with a valid visa giving them a right to work in the UK can apply for jobs. Harrow Council offers free training and employment for residents. This programme is called Xcite and it provides a full range of support to help Harrow residents into work. They can advise you on:

- apprenticeships
- improving your skills
- job search
- writing CVs and applications
- performing at interviews
- getting into construction
- business mentoring
- vocational skills

Getting a National Insurance Number

Anyone over the age of 16 wishing to work will need to apply for National Insurance Number. Individual National Insurance numbers (NINO) are used to track each person's record in paying tax contributions. Anyone's NINO is unique: they use the same number throughout their life.

You can only apply for a NINO if you are in the UK. Applications are made online, and you need to have a passport and the Biometric Residence Permit showing your right to work in the UK.

After you apply, you'll get an email with your application reference number. The email will tell you if you need to provide more proof of your identity. It can take up to 8 weeks for you to get your National Insurance number after you have proven your identity. Wages and deductions

Employers in the UK must pay their employees at least the minimum hourly wage set by the government. The National Minimum Wage is the minimum pay per hour and almost all workers are entitled to. The National Living Wage is higher than the National Minimum Wage - workers get it if they're over 25. Anyone earning an income in the UK usually pays tax as National Insurance Contributions and Income Tax. The Income Tax rates differ by income and every person is entitled to a non-taxable Personal Allowance of £12,570 per year. This amount can change each year. The financial year or the tax year in the UK lasts from April to March next year.



Problems at work

Organisations such as ACAS provide free advice and support to employees who are facing difficulties at work, including disputes and discrimination. The ACAS helpline is for anyone who needs employment law or workplace advice, including employers, employees, and workers.

Contact them for confidential, free advice. They can advise you on:

- any work-related problem or question you have
- what the law says and how it relates to you
- good practice at work
- your options, including any risks and benefits

Opening a bank account

Card payments are widely used across the UK and in Harrow. Most employers would also want to pay your wages into your bank account (by bank transfer). You can contact any local bank and ask if you can open a current bank account. Some banks such as NatWest and Royal Bank of Scotland (RBS) are offering bank accounts to Ukrainian nationals in the UK:

Housing and welfare access

After you have arrived in Harrow, you may need to find alternative accommodation for you and your family. There are several options for this. You could search for private rented accommodation with the help of an estate agent or by searching local offers in newspaper or online adverts.

Tenants usually need to pay Council Tax, which is a yearly fee payable to Harrow Council and that helps fund services such as maintaining the infrastructure, street cleaning, libraries, parks maintenance, and other services delivered by the Council.



Your rights

As a tenant, your rights are protected and usually you will be provided with a tenancy agreement specifying your rights and obligations. If the property you are renting is in poor condition you should contact your landlord and ask them to improve the conditions of your home.

If you are unable to arrive at a reasonable agreement with your landlord, you can contact the housing advice team in the council for professional advice or you can report the property at www.harrow.gov.uk/housing-property/report-issue-privately-rented-accommodation.

Social care

Harrow Council social services are a statutory service to safeguard and promote the welfare of vulnerable children and adults. Social services can provide a wide range of services to children and their parents, usually within the own home and co-ordinated by a social worker.

Staying safe

Abuse

Domestic abuse is a serious crime in the UK, and it can include emotional, psychological, controlling or coercive behaviour, sexual and/or economic abuse. It can escalate and have a serious impact on you, your children, and any other family members exposed to abusive behaviours. Police

If you are the victim of a crime (including hate crime), see a crime happening, or for general assistance (for example, if you are lost) the Police can help you and you should not be afraid to approach them.

To report a crime, you should call the following telephone numbers:

- 999 This is the number to call in an emergency. For example, if you are the victim
 of an assault or see a crime taking place. Ask for the 'police' when you get through.
 This is also the number to call if you need an ambulance or if there is a fire.
- 112 is a common emergency telephone number that can be dialled free of charge from most mobile telephones, and in some countries, fixed telephones to reach emergency services - ambulance, fire and rescue, police.
- 101 This is the number to call for less urgent situations. For example, if your property has been damaged.

Places of Worship

Harrow is a religiously diverse borough with everyone free to practice their own faith. There are various places of worship in Harrow, including Christian Catholic and Orthodox churches, mosques, temples, and synagogues and information on where these are in our borough can be found online.

Shopping

Harrow Town Centre is the main shopping district in the borough. However, there are plenty of local shopping parades in each neighbourhood with a variety of groceries, restaurants and other shops.

If you are shopping in person, you may want to carry a bag with you as everyone is encouraged to avoid using single-use plastic bags and shops need to charge a small fee for each single-use plastic bag they sell.

It is very common for people to shop online. If you do so, please be mindful of risks such as identity fraud, scams, phishing attacks, and sharing your card details on websites that are trusted.



Banks usually charge a commission and apply an exchange rate that may be lower than that practiced by other currency exchange services when you are paying for purchases and services online, in the UK if you are using a bank card that was issued in another country. You can speak to the issuing bank in the respective country to find out what fees they charge and what exchange rates they are applying for your currency and GBP.
