Thank you for your email.

I can confirm that there are no existing heat networks within the immediate vicinity of the site that would be likely to be capable of feasibly serving the subject development. This is due to its modest size and distance from any identified network on the London Heat Map or those not shown (i.e. likely network at RNOH or the recent Elysian development next to Stanmore Station - both a considerable distance away given the site's Green Belt location.)
