Assessment of Venues put forward by members of the public during the Former Brockley Hill Golf Centre public inquiry (APP/M5450/W/22/3299650)

1. This note presents an analysis of the additional venues put forward by members of the public during the inquiry into this appeal. It is a Supplemental Briefing Note to the evidence of Ms Amy Gilham.

2. It sets out:

- (a) The names of the additional venues put forward by members of the public on 11 October (Tables 1 and 2)
- (b) A summary of my findings in relation to these additional venues
- (c) Crib sheets on each venue put forward on 11 October (Appendix 1)
- (d) A summary of my findings in relation to further additional venues put forward subsequently on 13 October (supporting information contained in Appendix 2)
- (e) Information about the religious affiliation (if any) every venue considered within my Proof of Evidence, Rebuttal and the additional venues (supporting information contained in Appendix 3). This information is provided in response to a request from the Inspector.
- 3. As I explain in detail below, none of the additional venues put forward by members of the public during the inquiry presents a fully comparable offer to the Appellant's 'Premier Banqueting' proposal.
- 4. A total of 36 venues were put forward over the course of the inquiry (17 venues on 11 October and 19 venues on 13 October). I had covered 10 of these venues within my Proof of Evidence and Rebuttal. Ten of the venues are located outside of the sub regional market area and are therefore not relevant to the analysis. Sixteen venues within the sub-regional market area were therefore taken forward for analysis within this note.
- 5. Half (8) of these 16 venues do not meet the threshold criterion of being able to accommodate a minimum of 300 guests in banqueting style. These 8 venues therefore rated Red. Another venue is not yet operational and is still seeking £2m to fund its development. A total of 9 venues do not therefore meet the basic criteria of being operational and being able to accommodate the requisite minimum capacity.

- 6. Of the remaining 7 venues none is fully comparable with Premier Banqueting's offer. None provides a dedicated 'one-stop-shop' banqueting venue able to meet the range of needs of the South Asian and other ethnic community with regards to weddings.
- 7. My findings in this note do not therefore change the main conclusion that I reached in my Proof of Evidence and Rebuttal. Following the closure of Premier Banqueting's previous venue and the VIP Lounge in Harrow, there is unmet need for a dedicated 'one-stop-shop' banqueting venue able to meet the needs of South Asian and other ethnic communities in the London Borough of Harrow.
- 8. It remains the case that there are only 5 such 'one-stop-shop' venues (rated Green in my Proof of Evidence) elsewhere in the sub-regional market area. To reiterate, none of these 5 venues is in the Borough of Harrow it being the authority area with by far the highest concentration of persons with the relevant protected characteristics in the sub-regional market area.

Additional venues put forward by members of the public (11 October)

- 9. In Table 1 overleaf, I have set out the 17 venues mentioned by members of the public during the public inquiry on Tuesday 11th October 2022 as later confirmed on 13th October 2022. These venues fall into three categories:
 - Venues covered in my own Proof of Evidence/Appellant's statement of case: 5 venues
 mentioned by members of the public are within the sub-regional market area and I have
 already considered them in my original Proof. I do not consider these further here, although I
 do include them for comparison in Appendix 3.
 - Venues not in sub-region: 2 of the venues identified by members of the public do not lie
 within the identified sub-region (Harrow, Barnet, Brent, Watford and Hertsmere) and so are
 discounted from further analysis. This is in accordance with the approach I took in my Proof
 of Evidence and Rebuttal.
 - <u>Venues agreed for further review:</u> The remaining 10 venues identified by members of the public were not included in my Proof of Evidence but do fall within the sub-regional market area. These venues are the main subject of this note.

Overview of Findings

- 10. I undertook a desk-based review of each of the 10 venues which fall within the sub regional market area but which I had not assessed previously. This included a review of published information on venues' websites, additional information where available elsewhere online together with telephone and email exchanges with representatives of those venues to gather additional information where required. I used the same research and assessment methodology when preparing my original Proof of Evidence and subsequent Rebuttal.
- 11. Of these 10 venues, 7 are located in the Borough of Harrow. In summary, I made these findings after researching the 7 venues:
 - None of the venues is rated green and therefore none is fully comparable with Premier Banqueting's offer. There remains, no fully comparable 'one-stop-shop' banqueting facility within the London Borough of Harrow.
 - 4 venues in Harrow meet some but not all of the requirements. These 4 venues are not fully comparable with Premier Banqueting's offer. I have rated these Amber.



- 2 venues do not meet the requirements. One has capacity below the minimum of 300 guests in banquet style seating and the other has confirmed that they do not hold weddings but engagements only. I have rated these Red.
- 1 venue in Harrow is in development and is not yet open. In accordance with the approach I have taken elsewhere I therefore do not include this within the supply position.
- 12. My conclusion therefore remains that there is an unmet need following the closure of Premier Banqueting and the VIP Lounge for a dedicated 'one-stop-shop' banqueting venue to meet the needs of the South Asian communities (and other ethnic communities) within the London Borough of Harrow.
- 13. Of the other three venues put forward:
 - Two are in Hertsmere. One is rated Amber and the other Red.
 - One is in Brent and is rated Red.

Further Additional Venues Put Forward by members of the public (13 October)

- On Thursday 13th October, contrary to the spirit of the exercise undertaken at the inquiry on 11th October to identify all additional venues that the public were inviting the Appellant to consider, Dr Khanderia sent a list of 17 further additional venues to the Council that had not even been mentioned at the inquiry on 11th October. It was agreed with the Inspector that these venues should be the subject of no more than brief commentary as opposed to detailed assessment. I have indicated the findings of my desk-based research and my enquiries of these venues in Appendix 2.
- 15. In Table 2 below, I have put the further additional venues put forward by Dr Khanderia in his note on Thursday 13th October 2022 into three categories:
 - <u>Venues covered in my own Proof of Evidence/Appellant's statement of case:</u> 5 venues put forward by Dr Khanderia are within the sub-regional market area and I have already considered them in my own Proof. I do not consider these further here, although I do include them for comparison in Appendix 3.
 - <u>Venues not in sub-region:</u> 8 of the venues identified by Dr Khanderia do not lie within the identified sub-region (Harrow, Barnet, Brent, Watford and Hertsmere) and so are discounted from further analysis in accordance with the methodology I applied elsewhere.
 - <u>Venues for further review:</u> The remaining 6 venues identified by Dr Khanderia were not included in my Proof (some of them I discounted at an earlier stage of the analysis for reasons that included a lack of capacity, unavailability and/or conflicting uses).

Overview of Findings

- 16. Of the 6 venues put forward by Dr Khanderia which are within the sub regional market area and not considered elsewhere in my analysis, 3 are located within the Borough of Harrow. In summary, I made these findings after researching the 3 venues put forward in Harrow is as follows:
 - None of the venues is rated green and therefore none is fully comparable with Premier Banqueting's offer there remains no fully comparable banqueting facility within the London Borough of Harrow.
 - 1 venue in Harrow meets some but not all of the requirements and I therefore rated this Amber.
 - 2 venues do not meet the requirements, for example they have capacity below the minimum of 300 guests in banquet style seating. I have rated these venues Red.
- 17. Of the other 3 venues put forward within the sub regional market area:
 - 1 is in Watford and is an extremely high-end hotel in the "super luxury" category with a spa, golf course and a focus on corporate entertainment and conferences. It is an exclusive venue associated with the rich and famous and therefore is not an appropriate comparator in terms of affordability. Only a very small proportion of families from South Asian communities would be able to afford a wedding at this venue. It is surprising that it



has been put forward for consideration given the comments made by some members of the public at the inquiry about the importance of affordability to most people when organizing a South Asian wedding. In addition, South Asian weddings at this hotel are catered by a contracted external caterer, as opposed to in-house, thereby increasing the overall cost still further. I have rated this Amber.

- 1 is in Hertsmere and does not meet the requirements, as capacity is below the minimum of 300 guests in banqueting layout. I have rated this Red.
- 1 is in Barnet and does not meet requirements, as capacity is below the minimum of 300 guests in a banqueting layout. I have rated this Red.

Summary: All additional venues put forward by members of the public at the inquiry.

- 18. Table 3 overleaf summarises information about all the venues identified and put forward by members of the public which are located in the sub-regional geography.
- 19. I have identified where each venue meets (or does not meet) the criteria I applied in the initial assessment in my Proof and Rebuttal. An 'X' in the table indicates that the criterion is met.
- 20. It is evident that none of the venues meet all of the criteria. Where venues meet a number of criteria with regards to the specific wedding offer, there are overarching constraints on the use of the space as a wedding venue such as:
 - Guest capacity (these are automatically rated Red)
 - Wider uses of the venue limiting its availability or resulting in a conflict of uses
 - Future operation not guaranteed (for example, venue not yet operational or venue expected to relocate elsewhere).
- 21. My conclusion as set out in my Proof of Evidence and Rebuttal remains there is no fully comparable venue in Harrow providing a dedicated, 'one-stop-shop' banqueting venue to meet the needs of the South Asian communities (and some other ethnic communities) when organising weddings within the London Borough of Harrow. There is unmet need following the closure of Premier Banqueting and the VIP Lounge. There remain only 5 such venues across the wider sub-regional market area, none of which are in Harrow which has the highest concentration of persons with relevant protected characteristics.

Religion

- 22. The Inspector asked for confirmation of the religious affiliation (if any) of each venue considered. I have provided this information in Appendix 3. I have done this for every venue covered in my Proof of Evidence, Rebuttal and this note. I have also indicated where venues are not affiliated with a particular religion but are not able to accommodate stricter cultural and religious requirements.
- 23. It is important to stress that the affiliation of a venue with one particular faith, or even a subgroup within that faith, means that it will not typically be used by members of a different faith for marriage. Inter-faith marriages would also not take place at these venues.
- 24. This applies principally to temples or mosques but would also apply to community facilities affiliated with a particular religion.
- 25. Put simply, a Hindu family would not seek to host a wedding ceremony or banquet in an Islamic oriented centre. Conversely, a Muslim family would not seek to host a wedding ceremony in a Hindu oriented centre. Whereas the worship of statues (murti's²) is prominent in Hindu faiths, the Islamic faith does not permit the idolisation of.
- 26. There is a further limitation with regards to sub-groups within both Hinduism and Islam. For example, within the Muslim faith, Shia Muslims would be members of Shia Mosques and Sunni Muslims would be members of Sunni Mosques.
- 27. It is also necessary to recall the points I made in my Proof of Evidence that the Borough has an above-average representation (17.2%) of residents of 'other ethnic' origin (para. 5.4) (i.e. other than Indian and Pakistani) and that these communities comprised 38% of Premier Banqueting's event hosts (Figure 5.3). There is cultural diversity within these communities which can further restrict the appropriateness of using certain venues with particular religious affiliations.
- 28. The main points to emerge from my research into the governing religion (if any) of each venue (including those venues covered in my Proof, Rebuttal and the additional venues reviewed which are set out in Tables 1 and 2) are that:
 - The 5 Green rated venues in the sub regional market area (as identified in my Proof of Evidence) are not religious venues and are able to meet any host requirements. This is part of their universal offer as banqueting venues, in the same way as Premier Banqueting.
 - Of the venues within Harrow rated Amber³, 6 are religious (4 are Hindu, 2 are Muslim) and 4 are not restrictive (though they do not have a full banqueting offer).
- 29. Table 4 below provides a summary of venue rating by religion or restrictions for each of the five sub-regional market area authorities.

Room 3 – 110 guests in a banqueting layout

Rooms 1 and 2 can be combined to host up to 500 guests in a banqueting layout (see email below which indicates that it is not possible to host full weddings in this set up due to obstructing pillars)

There is a marquee available but no weddings, evening events or music permitted.

Height/Size for staging

No - The Blue Room does not provide adequate room for a mandap since the ceiling is less than 10ft in height. We are aware of an image of a mandap on the venue's website however the manager at the venue confirmed the position as per the two emails below:

Dear Sirs Further to our conversation, although we do some weddings at Blue Room it's not used very often mainly due to the ceiling heights. Our ceiling is less than 10ft which doesn't give the clearance for mandaps. We focus mainly on restaurant and live music events on the weekends. Many thanks Binod Manager Blue Room Sent from my iPhone Further confirmation received by email received 19 October 2022 To provide some assistance our ceiling height is less than 10ft which doesn't allow for stage and mandap inside the venue. When we do put one up it's not on a stage and hence why our venue is not really used much for weddings. You can see these picture of mandap on website how close it's to the ceiling. Customers when they source mandaps use from external suppliers. A wedding couple would need to organise the decor. Although 2 of the function rooms can be opened up, there are columns in place which doesn't allow viewings of weddings. We cannot hold 500 banquet with full weddings in the venue because we have pillars obstructing. 
