The Harrow (Parking Places) (Amendment No.*) Traffic Order 20**

The Harrow (Free Parking Places) (Amendment No. *) Traffic Order 20**

1. NOTICE IS HEREBY GIVEN that the London Borough of Harrow proposes to make the above mentioned Orders under sections 6, 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985 and all other enabling powers.
2. The general effect of the Parking Places Order would be:
 - (a) to amend the maximum stay and no return period restrictions in parking places in certain lengths of the streets listed in Schedule 1 to this Notice;
 - (b) to revoke the provision for Paid for Parking in certain lengths of the streets listed in Schedule 2 to this Notice;
 - (c) to designate paid for parking in certain lengths of the street listed in Schedule 3 to this Notice;
 - (d) to designate permit parking places in certain lengths of the streets listed in Schedule 4 to this Notice;
3. The general effect of the Free Parking Places Order would be:
 - (a) to designate free parking places, which will be subject to maximum stay and no return period restrictions in certain lengths of the streets listed in Schedule 4 to this Notice;
 - (b) to amend the maximum stay and no return period restrictions in parking places in certain lengths of the streets listed in schedule 5 to this Notice;
 - (c) to revoke the provision for free parking places in certain lengths of Uxbridge Road.
