The Council of the London Borough of Harrow, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a) and of all other enabling powers, hereby make the following Order:-

- 1. This Order shall come into operation on *** 202* and may be cited as The Harrow (Prescribed Routes) (No. *) Traffic Order 202*.
- 2. No person shall cause any vehicle to proceed in that length of the access road which lies between the south-western kerb-line of Pinner Road, North Harrow and the Cambridge Road Car Park in a direction other than from north-east to south-west.
- 3. Nothing in this Order shall apply to:-
 - (a) to anything done with the permission or at the direction of a police constable in uniform;
 - (b) to any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.
