Notice of proposal to construct speed cushions

Clamp Hill

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Harrow proposes to make the above-mentioned Order under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985 and all other enabling powers.
2. The general effect of the Waiting and Loading Order would be :-
 - (a) to introduce "At Any Time" Waiting Restrictions in certain lengths of Clamp Hill and Acacia Close;
 - (b) to reduce "At Any Time" Waiting Restrictions in certain lengths of Clamp Hill.
3. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Harrow proposes to construct speed cushions under section 90 A-F of the Highways Act 1980.

The location of the cushions will be in Clamp Hill, generally adjacent Nos. 2-3, 8-9, "The Lodge", "Hermitage Gate", the south-western end of the bus stop adjacent the access road to "Bentley Wood High School for Girls", "Belgrano House", "Sparkbrook", "The Haven", south-west of the access to "Jacques Garden Centre", north-east of the access to "Jacques Garden Centre" and "Harrow Weald Scouts" hut.

4. A copy of the proposed Order, of a map of the relevant area, of relevant previous Orders and of the Council's statement of reasons for proposing to make the Orders can be inspected until the expiration of a period of 21 days from the date on which this notice is published at Greenhill Library, Perceval Square, College Road, Harrow, HA1 1GX between 10am and 6pm Monday to Saturday and 11am and 3pm Sunday, excluding bank holidays.
