## Election of a Greater London Assembly Member for the Brent & Harrow Constituency

- (1) If the election is contested, the poll will take place on **Thursday 2<sup>nd</sup> May 2024**
- (2) Nomination Forms for this election may be obtained from the Constituency Returning Officer, Electoral Services, Brent Civic Centre, Engineers Way, Wembley, HA9 0FJ
- (3) Nomination papers must be delivered to the Constituency Returning Officer, Electoral Services, Brent Civic Centre, Engineers Way, Wembley, HA9 0FJ between the hours of 10am and 4pm on or after the date of this notice (excluding weekends and bank holidays), but not later than **4pm on Wednesday 27<sup>th</sup> March 2024**
- (4) Payment of the deposit of £1000 for standing as a candidate at the election can be made by BACs Detail given on request. Candidates or their agents are responsible for ensuring that cleared funds are received by **4pm on Wednesday 27<sup>th</sup> March 2024**
- (5) Applications to register to vote must reach the relevant Electoral Registration Officer \*\* by **midnight on the Tuesday 16<sup>th</sup> April 2024**. Applications can be made online at [www.gov.uk/register tovote](http://www.gov.uk/register tovote)
- (6) Applications to vote by post or to change existing postal or proxy arrangements must reach the Electoral Registration Officer \*\* by **5pm Wednesday 17<sup>th</sup> April 2024**. Applications can be made online at [www.gov.uk/apply-postal-vote](http://www.gov.uk/apply-postal-vote) and [www.gov.uk/apply-proxy-vote](http://www.gov.uk/apply-proxy-vote)
- (7) Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the relevant Electoral Registration Officer\*\* by 5pm on **Wednesday 24<sup>th</sup> April 2024**. - (9) Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer \*\* by **5pm on Thursday 2<sup>nd</sup> May 2024**
