TEMPORARY ROAD CLOSURE - GAS PROJECT 1

THE COUNCIL OF THE LONDON BOROUGH OF HARROW HEREBY GIVE NOTICE that they have made a Temporary Traffic Management order under the provisions of Section 14 (1) (a) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991. This is to facilitate utility works.

- 1. The order may be cited as The Harrow (Gas Project 1) Temporary Traffic Order 2024, and shall be operational on 15th April 2024 and shall remain in effect until 31st October 2024 or until the completion of the works, whichever is the sooner. It is anticipated that all of the work should be complete by 28th June 2024.
- Vehicles shall be prohibited from entering or exiting;
 - i. Priory Way at its junction with Parkside Way
 - ii. Manor Way at its junction with Parkside Way
 - iii. Kingsway Crescent junction with Parkside Way
- 3. Vehicles shall be prohibited from exiting Kingsfield Avenue at its junction with Parkside Way/ Station Road, North Harrow.
- 4. Vehicles shall be prohibited from exiting Southfield Park at its junction with Station Road, North Harrow.
- Nothing in paragraph 2-4 above shall apply to:-
 - (a) any vehicle being used for ambulance, fire brigade or police purposes;
 - (b) anything done with the permission or at the direction of a police constable in uniform or a civil enforcement officer;
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or Section 67 of the Road Traffic Regulation Act 1984:
 - (d) any vehicles used in connection with the utility works;
 - (e) any vehicles needing to gain access to properties in the closed extents as far as is practicably possible.
- 4. The provisions of the order will not have effect unless all the signs in accordance with the provisions of the Traffic Signs Regulations and General Directions 2016 are displayed, removed or covered, or unless at the direction of a police constable in uniform or a civil enforcement officer.
- Diversion route;
 - i. Via; Parkside Way, Manor Way and Headstone Lane and vice versa
 - ii. Via; Parkside Way, Priory Way and Headstone Lane and vice versa
 - iii. Via; Parkside Way, Pinner View, Kingsfield Avenue and Kingsfield Crescent and vice versa
 - iv. Via; Kingsfield Avenue, Pinner View and Parkside Way
 - v. Via: Southfield Park, Pinner Road and Station Road, North Harrow
