Statement of reasons:

The proposed measures in Spencer Rd will help to address the concerns of the local residents and businesses by removing commuter/non-resident parking which will free up road space for the local residents and businesses.

The Harrow (Parking Places) (Amendment No. *) Traffic Order 202*

The Harrow (Waiting and Loading Restrictions) (Amendment No. *) Traffic Order 202*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Harrow proposes to make the above-mentioned Orders under Sections 6, 45, 46, 49, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and all other enabling powers.
2. The general effect of the Parking Places Order would be to further amend the Harrow (Parking Places) Traffic Order 2020 so that:-
 - (a) residents and shared use parking places in certain lengths of Spencer Road would be redesignated from Controlled Parking Zone "CA" to Controlled Parking Zone "J";
 - (b) provide that any resident whose usual place of abode is Nos. 1- 41, No. 43 Spencer Road or Nos. 9-14 Lamorna Court, Spencer Road may apply to the Council for the issue of a residents permit valid for use in the designated parking places in Spencer Road and other relevant Permit Parking Places within the J Zone;
 - (c) provide that the residents of addresses listed in this notice would no longer be eligible to apply for permits for Zone CA;
 - (d) the charges for residents permits would remain unchanged;
 - (e) the times of operation for permit and shared use parking places in Spencer Road would be 7am to Midnight, Monday to Sunday;
 - (f) all provisions relating to the designation of Parking Places and Payment for Parking Places and Permit Provisions would remain unchanged.
3. The general effect of the Waiting and Loading Restrictions Order would be to be to further amend The Harrow (Waiting and Loading Restriction) Traffic Order 2014, so that waiting by vehicles, other than for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 40 minutes in the same place, would be prohibited between 7am and Midnight, Monday to Sunday in certain lengths of Spencer Road.
4. A copy of the proposed Orders and of the Council's statement of reasons for proposing to make the Order can be inspected until the expiration of a period of 21 days from the date on which this notice is published at Greenhill Library, Perceval Square, College Road, Harrow, HA1 1GX between 10.00 a.m. and 6.00 p.m. Monday to Saturday and 11.00 a.m. and 3.00 p.m. Sunday, excluding Bank Holidays.
