 - The John Lyon School, Middle Road, on both sides, between a point 10.00 metres north-east of a point opposite the party wall of Nos. 29 and 31 Middle Road and a point 25.56 metres north-east of that point 7.30am 5.00pm Mon Fri.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Harrow (Prohibition of Stopping Outside Schools) Traffic Order 2017(c) shall have effect as though the items numbered 18 and 46 in the Schedule to that Order were substituted with the items similarly numbered and set out in the Schedule to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order further amends the Harrow (Prohibition of Stopping outside Schools) Order 2017, so that the restrictions imposed by that Order on vehicles, with certain exceptions, with regard to stopping outside schools in certain streets in the London Borough of Harrow, now apply in additional lengths of roads within the Borough.
