SECTION 14(1)(a) ROAD TRAFFIC REGULATION ACT 1984 AS AMENDED BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

TEMPORARY ROAD CLOSURE – CARRIAGEWAY RESURFACING NO. 2

THE COUNCIL OF THE LONDON BOROUGH OF HARROW HEREBY GIVE NOTICE that they intend to make a Temporary Traffic Management order under the provisions of Section 14 (1) (a) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991. This is to facilitate carriageway resurfacing works.

1. The order may be cited as The Harrow (Carriageway Resurfacing No. 2) Temporary Traffic Order 2025, and shall be operational on 12th June 2025 and shall remain in effect until 1st February 2026 or until the completion of the works, whichever is the sooner. It is anticipated that all of the work should be complete by 1st August 2025.
2. Vehicles shall be prohibited from entering or exiting the following roads, when signs are in place;

3. Vehicles shall be prohibited from travelling in a southbound direction on Honeypot Lane, between its junctions with Broadcroft Avenue and Streatfield Road on 17th July 2025 between 19:00hrs and 05:00hrs.
4. The provisions of Item 10 of Schedule 5 to The Harrow (Prescribed Routes) (Harrow Town Centre) (No.10) Traffic Order 2011 shall temporarily be suspended. Vehicles shall temporarily to allow to enter the section of Vaughan Road between a point 24.00 metres west of the eastern wall of No. 24 Bessborough Road, and a point 34.00 metres west of that point, during the temporary road closure only.
5. Nothing in paragraph 2, 3 and 4 above shall apply to:-
 - (a) any vehicle being used for ambulance, fire brigade or police purposes;

- (b) anything done with the permission or at the direction of a police constable in uniform or a civil enforcement officer;
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or Section 67 of the Road Traffic Regulation Act 1984;
 - (d) any vehicles used in connection with the carriageway resurfacing works;
 - (e) any vehicles needing to gain access to properties in the closed extents as far as is practicably possible.
6. The provisions of the order will not have effect unless all the signs in accordance with the provisions of the Traffic Signs Regulations and General Directions 2016 are displayed, removed or covered, or unless at the direction of a police constable in uniform or a civil enforcement officer.

Honeypot Lane	via Kenton Road, Kenton Lane and Streatfield Road and vice versa;
Canning Road	via George Gange Way, Palmerston Road and Byron Road, Wealdstone;
Collier Drive	via Constable Gardens, Millais Gardens and Cotman Gardens and vice versa;
Culver Grove	via Crowshott Avenue, Honeypot Lane and Streatfield Road and vice versa;
Merlins Avenue	via Malvern Avenue, Alexandra Avenue and Minehead Road and vice versa;
Minehead Road	via Merlins Avenue, Malvern Avenue and Alexandra Avenue and vice versa;
Kenton Lane	via Streatfield Road, Culver Grove, St Andrews Drive and Weston Drive and vice versa;
Kenton Lane	via Streatfield Road, Honeypot Lane and Kenton Road and vice versa;
D’Arcy Drive	via Charlton Road, Kenton Road, Shrewsbury Avenue and Loretto Gardens and vice versa;
Honeypot Lane (southbound closure)	via Crowshott Avenue, Culver Grove and Streatfield Road.
