

**Statement of Representations Procedure  
Harrow Local Plan 2021–2041: Main Modifications Consultation**

**Planning and Compulsory Purchase Act 2004 (as amended), section 20(7C)  
Town and Country Planning (Local Planning) (England) Regulations 2012 (as  
amended), in particular regulation 35**

**Consultation period: 11:59 am on Monday 10 November 2025 to 12:01 pm on  
Tuesday 23 December 2025**

**1. Purpose of this statement**

This statement explains how to view the consultation documents and how to make representations on the proposed Main Modifications to the Harrow Local Plan 2021–2041. The Plan was submitted for independent examination on 26 February 2025.

The consultation is being carried out at the request of the independent Planning Inspector who is examining the Plan. It is not an opportunity to make new comments on parts of the submitted Plan that are not proposed for Main Modifications. Comments can only be made on the proposed Main Modifications schedule and related documents (see below).

Representations will be provided to the Inspector and will be taken into account before the Inspector issues her final report and final schedule of Main Modifications.

**2. Documents subject to consultation**

The following documents are published for consultation between 11:59 am on Monday 10 November 2025 and 12:01 pm on Tuesday 23 December 2025:

1. Schedule of Main Modifications to the Harrow Local Plan 2021–2041;
2. An updated Policies Map (online only) and Atlas of Change. These identify changes to the Policies Map that are needed to give effect to a Main Modification; and
3. Updated Integrated Impact Assessment (IIA) (including Sustainability Appraisal, Habitats Regulations Assessment and Non-Technical Summary).

The Council has also published a list of Additional Modifications. These do not materially affect the Plan so they are not being consulted on and comments on them will not be passed to the Inspector but will be considered by the Council.

### **3. Subject matter**

The Main Modifications are changes the Inspector considers are necessary to make the Local Plan sound and legally compliant under section 20(7C) of the 2004 Act. The consultation is therefore limited to whether the proposed Main Modifications, the related Policies Map changes (that give effect to a Main Modification) and the updated Integrated Impact Assessment (IIA) are sound and legally compliant. The publication of the Main Modifications is without prejudice to the Inspector's ultimate conclusions and recommendations on the Plan.

You should not use this consultation to:

- repeat previous representations on the Regulation 19 Plan,
- comment on parts of the Plan that are not proposed for modification,
- seek new sites or broad policy changes which do not arise from the modifications.

### **4. Period for submission of representations**

The consultation period runs for six weeks from 11:59 am on Monday 10 November 2025 to 12:01 pm on Tuesday 23 December 2025.

Representations must be received no later than 12:01 pm on Tuesday 23 December 2025. Late representations cannot be accepted and will not be forwarded to the Inspector.

## **6. How to make a representation**

Representations may be made at any time between **11:59 am on Monday 10 November 2025** and **12:01 pm on Tuesday 23 December 2025** in any of the following ways:

Please provide:

- your name, organisation (if relevant), and contact details,
- the Main Modification (reference number, paragraph, policy or map change) you are commenting on,
- whether in your view the modification is legally compliant and sound,
- if unsound which test or tests of soundness it fails (positively prepared, justified, effective, consistent with national policy),
- the change you are seeking,
- whether you wish to participate at any further hearing session the Inspector may hold or be informed of the progress of the Examination.

Anonymous comments cannot be accepted because all representations must be attributable to an identified person before being sent to the Inspector. All representations will be made public but personal contact details will be processed in line with the Council’s privacy notice.

## **7. What will happen to my representation**

When the consultation closes at 12:01 pm on Tuesday 23 December 2025 the Council will:

1. prepare a schedule of all duly made representations, and
2. send it to the Planning Inspector together with the consultation documents.

The Inspector will decide how the representations should be considered. Everyone who makes a duly made representation will be notified of the next formal stage of the examination including receipt of the Inspector’s report and adoption.

## **8. Data protection**
