Statement of reasons:

Changes are proposed to remove parking bays and re-introduce waiting restrictions outside No. 15 Flambard Road; outside the flank wall of No. 10 Cavendish Avenue, situated in Rye Way; outside No. 53 The Highlands; and outside Nos. 48 and 50 Turner Road. These proposals are to allow vehicle crossovers to be constructed for access to private parking within residential properties.

This Order is being proposed for the following reasons:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (c) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- (f) for preserving or improving the amenities of the area through which the road runs

In authorising the advertisement of these proposals, the Council has given consideration to its duty under s.122 of the Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway (while having regard to the matters specified in s.122 subsection (2) of that Act).

 - (b) for the item in Table 1 of Part 4 to Schedule 19 to that Order numbered 3 there were substituted the item similarly numbered and set out in columns 1, 2, 3 and 4 of Schedule 2 to this Order;
 - (c) for the items in Table 1 of Part 3 to Schedule 27 to that Order numbered 9 there were substituted the items similarly numbered and set out in columns 1, 2, 3 and 4 of Schedule 3 to this Order;
 - (d) for the item in Table 1 of Part 3 to Schedule 46 to that Order numbered 1 there were substituted the item similarly numbered and set out in columns 1, 2, 3 and 4 of Schedule 4 to this Order;
