Statement of Reasons

In June 2022 and July 2023, the council received two petitions signed by residents of Victor Road, Albert Road, Sidney Road, Pinner View (north of Headstone Gardens), Edward Road, Fairfield Drive, Downing Close and Atherton Place.

The petition requested the council undertake a consultation in the area and to introduce a Controlled Parking Zone (CPZ) to help improve parking opportunities for residents.

A further petition requesting parking controls was received in June 2023 from residents of Harley Road and Harley Crescent, which is situated to the west and south of the new Eastman Village development, formerly the Kodak Factory site

The issues raised in the petitions included:

- Displaced non-residential parking from nearby Controlled Parking Zones.
- Residents being unable to park near their homes.
- Visitor parking for businesses on The Quadrant.
- Residents of surrounding Controlled Parking Zones parking in uncontrolled roads to avoid permit costs.
- Reports of dangerous parking and speeding.
- Users of the Caryl Thomas Clinic and Harrow Crown Court, parking in the unrestricted roads during weekdays for long periods.

It should be noted that Eastman Village development will comprise 2000 new homes, offices, restaurants, cafes and shops when completed. This scheme could have an impact on parking across the area, especially if the hours of operation of the existing CPZ are extended in that zone at any stage.

Following the Traffic and Road Safety Advisory Panel (TARSAP) meeting in May 2024, the Panel agreed to include the area detailed in the attached plan titled, 'Headstone Drive/Harrow View Area Controlled Parking Zone Consultation' in the council's Parking Programme for 2024-25.

Further to above consultation, the Council have decided to introduce a Permit Parking Area in Albert Road, Atherton Place, Downing Close, Edward Road, Fairfield Drive, Sydney Road and Victor Road on an experimental basis for 18 months. Within this experimental order, the Council will also amend waiting and loading restrictions on parts of Eastman Road, Harrow View, Headstone Gardens and Newman Avenue

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Harrow has made the above-mentioned Orders under Sections 9 and 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985 and all other enabling powers.
- The general effect of the Experimental Order will introduce a new Permit Parking Area (PPA) incorporating Albert Place, Atherton Place, Downing Close, Edward Road, Fairfield Drive. Sidney Road and Victor Road. As well as the introduction of the PPA, there will be some changes to the waiting and loading provision on Eastman Road, Harrow Drive, Headstone Gardens and Newman Avenue.
- 3. The Order will come into operation on 5th January 2026.
- 4. A copy of the Order and of the Council's statement of reasons for making the Order can be inspected until the expiration of a period of 6 months from the date on which this notice is published at Greenhill Library, Perceval Square, College Road, Harrow, HA1 1GX between 10.00 a.m. and 6.00 p.m. Monday to Saturday and 11.00 a.m. and 3.00 p.m. Sunday, excluding Bank Holidays.
- 5. Further information may be obtained by contacting the Transportation Service at transportation@harrow.gov.uk.
- 6. The Order provides for the Strategic Head of Traffic, Highways and Asset Management, or any person authorised by them to modify or suspend the Order or any provision of it, if it appears to them or that person essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by the Order runs.
- 7. If the provisions of the Order continue in operation for a period of at least six months, the Council will consider in due course whether the provisions of the experimental Order should be continued in force indefinitely by means of a permanent Order. Any person desiring to object to the making of an Order for the purpose of such indefinite continuation may, within six months of the experimental Order coming into operation, send a statement in writing of the objection and the grounds on which it is made to: Head of Traffic, Highways and Asset Management at transportation@harrow.gov.uk quoting reference 25-15 VR, before the aforementioned date.
- 8. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.

The Harrow (Paid Parking – Zone VR) Experimental Traffic Order 2025

Made 17th December 2025

Coming into operation 5th January 2026

The Council of the London borough of Harrow in exercise of its powers under Sections 9 and 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984(a), as amended by the Local Government Act 1985(b), and of all other powers thereunto enabling hereby make the following order:

- 1) This Order shall come into operation on 5th January 2026 and may be cited as The Harrow (Paid Parking Zone VR) Experimental Order 2025. This order will be in place for a maximum of 18 months.
- 2) In this Order, the expression "enactment" means any enactment, whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Harrow (Waiting and Loading Restrictions) Traffic Order 2014(c) shall have effect as though:
 - a) the item in Schedule 1 to that Order numbered 8, 36, 285, 311, 336, 424, 437, 823 and 951 there were substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order;
 - b) the insertion of Schedule 1 to include the items numbered 1294 and 1295 inserted and set out in columns 1, 2 and 3 of Schedule 2 to this Order; and
 - c) the items in Schedule 1 to that Order numbered 62 and 65 there were substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 3 to this Order;
- 4) Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Harrow (Parking Places) Traffic Order 2020(d) shall have effect as though:
 - a) Within Article 2 of the Parent Order, insert the following new Article:

"Permit Parking Area" Area has the same meaning as set out in Schedule 1 of Traffic Signs Regulations and General Directions 2016(e).

- b) for the items in Table 1b of Part 3 of Schedule 83 to that Order there were the items 1, 2, 3, 4, 5, 6 and 7 were inserted in Table 1 and set out in columns 1, 2, 3 and 4 of Schedule 4 to this Order; and
- c) for the items in Table 2 of Part 3 of Schedule 83 to that Order there were the items 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 were inserted in Table 1 and set out in columns 1 and 2 of Schedule 5 to this Order.
- 5) In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Strategic Head, Traffic, Highways and Asset Management (or such other officer of the council as holds the post of Traffic Manager as defined in section 17 of the Traffic Management Act 2004) may, if it appears to that officer essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend any provision of this Order, save that no modification shall make an addition.
