Various locations – Sinusoidal road humps

Notice of proposal to construct road humps under Section 90 Highways Act 1980.

NOTICE IS HEREBY GIVEN that the London Borough of Harrow proposes to construct sinusoidal road humps in lieu of existing speed cushions in various roads in the borough, as detailed below, under the powers conferred by the Highways Act 1980, and under all other enabling powers.

Therefore, full carriageway width, 3700mm metre long sinusoidal road humps of no more than 100mm high are proposed at the following locations:
